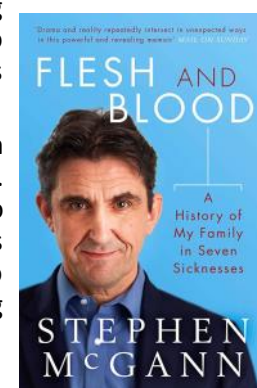
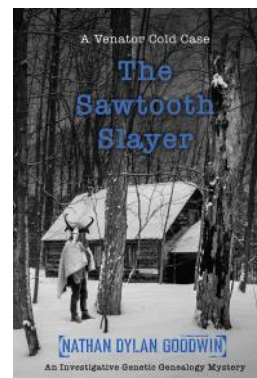
SAG's Online Book Club

On 21 February, The Society of Australian Genealogists had its first online Book Club meeting of the year. SAG members and guests were lucky enough to be joined by author Nathan Dylan Goodwin to discuss his genealogical mystery *The Sawtooth Slayer*, published in late 2022. Some readers may be familiar with Goodwin's 'forensic genealogist' series of books, and his work has been very well received, particularly by the family history community. The meeting provided an opportunity to discuss the ways in which books, whether fiction or not, can inspire readers in their own family history investigations. For example, *The Sawtooth Slayer* takes the reader step-by-step through a case and unmasks a killer using traditional DNA methods, with the advent of new technologies providing Goodwin with inspiration for his fiction. For genealogists, fiction can indeed have a lot to offer.

The SAG Book Club is a free event for all members of the SAG and is open to non-members for a fee. It is an occasion to share thoughts and moments from a book that have stuck with readers and discover things they hadn't noticed at first read. For those interested in the craft of writing itself, a discussion with an author about their writing process is enormously valuable. Authors who write about genealogy practice the delicate skill of balancing general enjoyment with the interests of a target audience of family history researchers.

The second session of SAG's Book Club for 2023 featured Stephen McGann, well-known as an actor, discussing his 2017 book *Flesh and Blood: A History of My Family in Seven Sicknesses*. McGann's book recounts a family history of immigration, illness, and survival. The book also demonstrates how to tie one's personal family history research in with the broader social histories in which their ancestors inhabited. This session provided another opportunity for SAG members to share their reactions and insights, as well as de-mystify the process of writing truly engaging family history.

FHACT Heritage Month Wrap Up

April 2023 marked the 40th Canberra and Region Heritage Festival. Family History ACT helped celebrate with five events during the month of April. It made for an incredibly busy month for our volunteers but also a very enjoyable one.

Our last event was a very successful **Library Open Day** attended by over 35 visitors. This included 25 who took advantage of our sessions for members of the public to talk with an experienced Society member to start to *Shake their Family Tree*. Some fascinating and helpful conversations were had.

The month started for us on 4 April with our **Father Brian Maher Lecture** which was delivered this year by Cheryl Bollard, our Treasurer and Project Leader for the Canberra Pioneers Project. The lecture was attended by over 50 people including ACT Heritage Minister Rebecca Vassarotti, who has discovered that she has connections to families in the Maher Collection, and by members of Fr Maher's family who were thrilled to learn of our efforts to preserve and make available Fr Maher's legacy.

A number of families joined our **Childrens Scavenger Hunt** on April 15th.

And while Barb Toohey and Cheryl were managing that activity at Riverside Cemetery in Queanbeyan, another group led by Mel McNamara was representing us at the **National Trust Open Day at Duntroon Dairy** where Canberra's beautiful autumn

Nick Vine Hall Award for 2022

Entries close 30 June 2023



The Nick Vine Hall Award is awarded annually to AFFHO member societies for the best family history journal or newsletter. AFFHO provides this award to encourage its member societies to produce quality communications for their membership in the form of journals or newsletters. The award also honours the work of Nick Vine Hall AM.

The competition is open to member societies of AFFHO in two categories:

- ◆ Category A – less than 500 members
- ◆ Category B – more than 500 members

Your journal or newsletter can be published digitally or in print format, and dated for 2022. The conditions of entry and the entry form are on the [AFFHO website](https://www.affho.org).

Nick Vine Hall AM was a recognised Australian authority in the fields of family history, genealogy and heraldry, and an enthusiastic champion of family history research in Australia. He

had a considerable flair for public relations and marketing skills, which he used to popularise family history research, and make social history a matter of serious pursuit in Australia.

Vine Hall was the chairman of the Australian Federation of Family History Organisations Census Working Party, which persuaded the Australian government to trial the voluntary retention of the 2001 national census. In February 2006, legislative changes made this trial a permanent feature of all future Australian censuses.

Among many other achievements, Nick Vine Hall joined the Heraldry and Genealogy Society of Canberra (HAGSOC) in 1988, he was a founding member of the Huguenot Society of Australia established in 2003, and in 2006 was made a Life Member of the Society of Australian Genealogists. After a long battle with cancer, he passed away in 2006 at the age of 62 in Melbourne, Victoria.

As genealogists and researchers, we must understand today's laws as much as yesterday's.

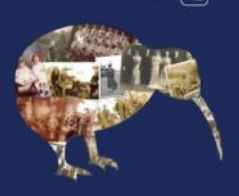
