NEWSPAPER ITEMS

Berrembea Pennant Presented 4th October 1943 Bundaberg News Mail

On Thursday, September 30, there was a gala day at the State School, when upwards of 50 parents and committee were present for the presentation of the War Savings Pennant won by the school in Kolan Shire War Savings Competition

The chairman of the Kolan Shire (Cr T J Campbell) accompanied by Mrs Campbell was welcomed by Mr Hilder, the head master.

Mr Campbell making the presentation conveyed to the pupils and teachers the sincere appreciation of the Commonwealth Government for their wholehearted support, and interest in the competition. The splendid effort of the children in Queensland, particularly Berrembea, during the competition subscribed over £100,000. To the war effort by the purchase of war savings stamps, an achievement of which the children can feel justly proud.

Mr Campbell congratulated pupils, head master and parents for their loyalty and support to such a worthy cause, and expressed the wish that every school in the Kolan Shire would contribute and take an active part in future war saving competitions

The pennant was presented to Ronald Ford, chairman of the school's Pine Project Club, as a representative of the school.

Cr Campbell took a keen interest in the Project Club's work. He inspected the 350 pine trees growing at the school, and remarked favourably upon their growth, care and attention given by the children since his last visit. He also expressed the appreciation of the parents of Berrembea to their teacher, Mr Hilder, who had been with them for 14 years, and although numbers in the school had dwindled, interest on his part had not waned as shown by winning the pennant in the Kolan Shire, and the work of the Project Club.

Mr H Schmidt moved and Mr J Stockwell seconded a vote of thanks to Cr Campbell for coming s far and taking such interest in the work of the children. Afternoon tea was served by a woman's committee.

The Bundaberg Mail and Burnett Advertiser 6th Dec 1916 Accident to A Lad

The second son of Mr and Mrs G H Wadsworth Walla Lagoon, on Friday afternoon running home from school tripped over some wire and broke his elbow, and was immediately brought into Gin Gin Hospital where Dr Kesteven set the limb and the lad is now doing all right.

The Bundaberg Mail and Burnett Advertiser 6th Dec 1916 Boxing

The Oddfellows Hall, Gin Gin, was crowded to witness the contest between Leslie Blair and John Deshong for £10 aside, best of 20 rounds, on Saturday night 2nd instant. The first two attractions were a two-round bout between R Honor and M Walker, the first named proving the winner: and G Gilmour and young Deshong, the winner, a lad of 18, knocking Gilmour out in the third round. At 9 o'clock the chief event took place. Deshong had the advantage of Blair by 2st in weight. The contest lasted the full 20 rounds, the referee, J O'Driscoll, giving the verdict to Deshong on points. The decision was fairly unanimous. Deshong looked a likely winner after the few rounds. It was stated that during the contest Deshong broke one of his fingers.

The Bundaberg Mail and Burnett Advertiser 6th September 1917 Cordalba-Dallarnil Stations

The stations at 20miles 20 chains, 32 miles 67 chains, 30miles 21 chains, 34 miles 59 chains, 38 miles 13 chains, 45 miles 18 chains, 49 miles 50 chains, on the Cordalba-Dallarnil are to be named respectively – Duloon, Booyal, Marule, Junien, Woolu, Kukar and Dallarnil.

The Bundaberg Mail and Burnett Advertiser 21st August 1915 Booyal Notes

Mr Harry Simpson has sold his farm to a Childers resident, and left to join his father and brother on a large far in Kingaroy.

The railway house at Wooloo has been moved to Mundabong and Mr McLennan from Marule is moving into it shortly. Mr J Holliday takes the house at Marule.

A siding is being erected at Junien.

Maryborough Chronicle 3rs June 1948

Tragedy at Childers

Childers January 2 – The lifeless body of Thomas William Oliver, 54, railway employee, was found about 8.45 pm last night lying, in the yard of his home at Marule. The discovery was made by members of his family, who, after hearing a short shortly after deceased left the house made an immediate search. A 22 rifle was found beside the body.

Police inquires revealed that there were no suspicious circumstances connected with the tragedy. It is understood however, deceased had been in ill-health for some time.

They will commence work towards the end of July. The contract price was £4119/11/4.

Bundaberg News Mail 20th August 1948

Mr Albert George Pegg, of Stewart Street, North Bundaberg, died at the Brisbane General Hospital yesterday aged 65 years.

Mr Pegg was a native of North Bundaberg the eldest son of Mr and Mrs Joseph Pegg. For many years he engaged in cane growing in the district and he carried off many prizes at Bundaberg Show, including the State Insurance Cup for championship six sticks.

In his youthful years Mr Pegg was a keen footballer.

He is survived by his brother Jack (North Bundaberg) and four sisters Mrs E Verrenkamp (North Bundaberg), Mrs Fred Courtice (Barolin), Mrs W Guthrie (Mackay) and Mrs C Ballantyne (Bundaberg).

The funeral will take place from the Church of England on Saturday morning. Arrangements in the hands of F C Brown & Co.

One son Leslie Arthur Taylor, Brisbane and 12 grandchildren.

Her funeral which is of a private nature will move from St Andrew's Presbyterian Church this Saturday morning after a service commencing at 10.30 am for interment in the Bundaberg General Cemetery.

Bundaberg News Mail 23rd August 1948 Immigrant For Bundaberg

John Gregory, an immigrant from Malta, believed to be the first to work in the Bundaberg sugar industry, arrived last week, and was secured by Mr C A Hill, of Springhill Plantation. He was one of 435 immigrants on the Strathmayer which arrived recently, and Mr Hill was happy to have the honour in securing the first for Bundaberg. Gregory, whose wife and three children are still in Malta, stated last night, that he was on duty in Malta throughout the war. The country he said was constantly bombed, and there was heavy loss of life. However the people stood up to it. and today they are settling down to ordinary life again. (Bundaberg News Mail 23rd August 1948)

SIX IN ONE GRAVE By Val Messer

Like everyone I have my brick walls but in more than forty years as a family historian what I have found the most difficult has been locating the burial places of family members.

Before Civil Registration, if we know where our family lived, we look at Church records to find the details we are seeking. In the years after Civil Registration some of these records can be harder to find particularly if those family members lived in the bigger cities. In England GRO indexes can help but in my experience these do not give as much detail as our Australian ones do. Similarly, I have found that purchasing an English death certificate again provides little detail.

One of my areas of research over many years has revolved around my late husband's maternal line of HELMORE. The family originated in Devon but our branch moved to London ca 1780. Some later lived in Kent. Finding their places of burial after Civil Registration has proved very difficult.

I purchased death certificates and Wills looking for clues as to place of burial and I searched newspapers hoping that I might find a funeral notice, all without success. I have subscribed to Ancestry and Find My Past for many years but had no luck with any records there until a couple of years ago. Find a Grave has proved a boon in some areas but not in London.

A few years ago I tried Deceased on line and found a number of family members in their index. Several were buried in Brompton Cemetery so I purchased some credits and was able to view the burial details. Later I found that Brompton burial records were available on Ancestry and also on Find My Past. The ones in Find My Past gave the most information. I was amazed at the details that I found.

The first burial was my late husband's 2g grandfather, George Henry HELMORE, who died in 1868. It was a private grave and was opened to an extra depth of 13 feet to allow for more

burials on top. Also listed in his record were the burial numbers of five more people buried in the same grave. Further details revealed that the plot was 6½ feet long and 2½ feet wide. George Henry's son, George, gave permission for his father's body to be removed from the Parish of St John, Westminster, to be buried in Brompton. He was buried at half past one o'clock on Tuesday 18th August 1868. Total burial cost was £6/1/-.

The second burial was of George Henry's widow, Elizabeth, who was buried on 13th December 1872, when the grave was opened to 11 feet. I found no more details for her burial.

On 14th February 1874 the grave was again opened to 11 feet when a one month old infant, Harold Helmore, was buried. He was the son of George Helmore and grandson of George Henry Helmore. There was some interesting detail in this record.

On George Henry's death his son George became the owner of the grave and the deed of grant issued on 31st October 1868 was delivered to George on 11th February 1870. There was also a memo in baby Harold's burial record stating that his body was placed to the side of the previous burial, that of his grandmother, Elizabeth.

The fourth burial was of George Henry's spinster sister, Emma, who was buried on 03rd July 1877 when the grave was opened to 9 feet. Interestingly there was a memo attached here stating that on 19th February 1897 the ownership of the grave passed to Agnes Amelia Helmore. She was George's daughter and was the sole beneficiary according to his Will. He died on 19th February 1897.

On 27th January 1908 it was opened again, this time to 8 feet, for the burial of George Henry's spinster daughter, Catherine. I found no further details with this burial.

The final burial was that of George Henry's youngest daughter, Emma, also a spinster, who was buried on 11th January 1917, with the grave being opened to 6 feet. There was a letter attached to the burial details. This was written by Georgina Ethel Helmore, on behalf of her blind sister, Agnes. They were Emma's nieces, daughters of her brother, George. As Agnes was the owner of the grave she had to give permission for her aunt to be buried there.

Most of the burials gave an exact time of burial and listed the costs incurred. When I found these burials I couldn't help but wonder about the work of the gravediggers in 1868 toiling to get to the depth of 13 feet in such a small space. I had no idea that I was going to find six family members all buried in the one grave. I don't believe that there is any headstone.

Finally with regard to burial records – In Deceased on line I found the cremation record of another family member in Norwood Crematorium and Cemetery in Lambeth in 1924. As well as the basic details of her age, date of death and cremation, and place of abode, it also recorded the length of time for the incineration, the quantity of gas consumed and what the coffin was made of.

Although these records do not pertain to Kent perhaps they may provide food for thought for anyone seeking burial records and the details that may be available on them.

A Brief History of Mulgildie Homestead

Author unknown and year unknown when written.

The Mulgildie story starts back in the 1800's when the Darling Downs was opened for selection. As the southern part of the state became more densely settled, the only way to go was either west or north. It was the moving north that resulted in the Burnett being settled. Sheep was a most important method of making a living, and as the settlement spread, so did the sheep runs.

In 1853, Edward Weinholt took over Jondaryan Station, and he also at that stage owned several other stations in the southern Downs. The MacKay brothers had at that stage owned Dalgangal of which Mulgildie was an outstation. Mackays sold to Dangar Bros. In 1862, and than Edward Weinholt in partnership with William Kent and William Ch Williams bought the property in 1873. When the Resumptions Act was passed in 1884. Dalgangal covered 312960 acres.

Mulgildie was the main sheep run on the Three Moon Creek, and continued to be so till the introduction of Speargrass which greatly reduced the worth of wool. This caused the owners to go out of sheep and go into cattle. The basis of cattle came from Victoria – mainly Hereford stock. Monto was the northern boundary and the main sheep paddock for Mulgildie.

Thomas Bailey was the caretaker manager who travelled from Dalgangal to Mulgildie. He had his eye on Cannidah at the time and finally purchased Old Cannidah in partnership with Caswell.

The Mulgildie run was finally purchased by B Hughes, when the area was divided for local selection.

The whole Mulgildie Station was then further divided when the government of the day decided on closer settlement in different. Mulgildie was still the focal point of the district, and subdivision was carried out with most of the prime country being cut into farming areas varying from 160 to 300 acres, depending on their distance from Three Moon Creek.

Mulgildie continued in the hands of the Hughes family until purchased by Warren Dowling. This section of the property was portioned off and is presently the Monto and District Historical Society's Mulgildie Homestead Stables complex.

Account E Stein, right of lease of sub A of portion 1059, parish of Littabella (Waterloo), 5 acres, improved and land, crop, structures, rights and privileges. Subs 36 and 37 of section 15, of resub 6 of Sub A, of portion 3 Fairview Street Mt Pleasant, East Bundaberg, with dwelling, outbuilding, Etc.

RESEARCH ASYLUM RECORDS AT QLD STATE ARCHIVES

This guide provides an overview of mental asylum records at Queensland State Archives. Queensland State Archives holds records for mental health patients from 1860 onwards. Prior to separation from New South Wales in 1859, there were no facilities for psychiatric treatment in the Moreton Bay region. Persons with mental health issues, or mentally disturbed persons were sent to Brisbane Gaol or possibly to an asylum in Sydney. Many of the mental asylum records at Queensland State Archives were created by the Public Trustee (formerly the Public Curator) and Queensland Health (and related agencies). Some records are subject to restricted access periods. Further information about access is provided below. The records can be found in ArchivesSearch (the Queensland State Archives' catalogue).

PUBLIC TRUSTEES RECORDS

The name of the Public Curator of Queensland changed to The Public Trustee of Queensland on 1 January 1979. It is responsible for the administration of deceased estates and trusts as well as other legal, financial and property services.

Access to Public Trustee records which are subject to a 75 year restricted access period is granted at the discretion of the Public Trustee. Queensland State Archives has a process for applying for access to these records. Please contact Queensland State Archives for details. Protective Management Files Circa1/1/1865–31/12/1995 Series ID S334 Access: 75 years This series consists of mental health patients' estate files for the Queensland institutions including Goodna/Wolston Park (formerly Woogaroo), Sandy Gallop (Ipswich), and Willowburn (Toowoomba). Originally titled 'insanity files', the files may include forms, correspondence, personal details, date/s of admission and discharge, or date of death, inter-departmental correspondence about financial, court and police matters, financial accounts such as statements of assets and liabilities, and property details. Search ArchivesSearch for the name of the patient; most protective management files are listed by the name of the patient. Not all protective management files were transferred to Queensland State Archives. If the name is not found in ArchivesSearch, you can search the open indexes to Protective Management files, Series ID S19469; you will need to apply for access permission to view closed indexes.

This series contains alphabetical and numerical indexes to Protective Management Files where the Public Trustee and previously the Public Curator and the Curator in Intestacy and Insanity managed the financial affairs of a person (adult or minor) with decision making disability. Details recorded include name, date of admission, year and file number, including any changes to a file number. Indexes were previously known as Insanity Registers, Indexes to Mental Hygiene Files and Indexes to Mental Health Files. Note that the indexes may contain language which is now considered offensive and may cause distress.

Wolston Park - Goodna (Park Centre for Mental Health Treatment, Research and Education) records are subject to a 100 year restricted access period. Queensland Health requires all applications for access to restricted records to be under Right to Information (RTI) legislation. Access is granted at the discretion of Queensland Health.
