THE REWARDS OF RESEARCHING EXTENDED FAMILY MEMBERS

My interest in research pushes me to look beyond the immediate family and I thought I would share some of my finds to encourage others to go that bit further.

My 5x great aunt ANN ROBERTS married JAMES DUFFIELD HARDING. He became a famous painter later in life and his portrait hangs in the National Portrait Gallery. He and a colleague invented improvements in drawing materials and

apparatus for the use of artists. A book he wrote called *On Drawing Trees* and *Nature* is still available at libraries around the world.

Another 5x great aunt MARIA ADAMS married JOHN WALLEN a prominent architect and surveyor who designed St. Marks Hospital in London. In 1817 Wallen joined other surveyors and builders to give opinion to the House of Commons that "the practice of employing children to climb and sweep chimneys should be abolished". They also asserted that mechanical devices should be used instead of children. Sadly the practice was not outlawed until 1867.

By tracking down the Executors to the Will of my 5x great grandfather WILLIAM EDWARDS, I not only found several more generations of family as they had all come down from Yorkshire together but they were very interesting people in their own rights. First was ZACCHEUS HUNTER a druggist/chemist who was listed as a Levigator, Importer of and Wholesale dealer in Leeches in the 1819 London P.O. Directory. Some of his ointment jars are still available at auction to this day.

The other Executor was THOMAS SOTHERAN who was a Stationer and became extremely well known in the book selling business. He was a co-owner of Sotheran's Antiquarian Bookshops which still trade today.

GEORGE CUSSONS was the brother of my 5xgreatgrandmothr ELIZABETH EDWARDS nee CUSSONS. George finished life as a well known cabinet maker in Westminster. He was a devout Christian who founded the Naval and Military Bible Society to see that sailors and soldiers each received a Bible. He wrote a Memoir which is online and gave me a huge amount of information about my more immediate family.

JAMES SIX was another distant connection by marriage and I found out that he invented the Six thermometer which I believe is still in use today. He was also a member of the American Philosophical Society.





There are more but I hope these are enough to pique your interest into further research – you learn some obscure history and sometimes more about your immediate family. The other thing is that the majority of my family were farmers, tradesmen, etc. but there's always the exceptions.



THE MISFORTUNES OF JANE TITMUS (AKA TITMOUSE) FORMERLY JANE MORRIS

From being a Cook/Dairy Maid in Middlesex, being convicted of theft and sentenced to death which was reprieved to transportation for life to a penal colony, this is the story of my Paternal 3rd Great Grandmother Jane Morris.

Her story starts at 10 Lower Belgrave Road, St George Hanover- Square on 22 November 1830 when Jane Morris was charged with stealing 4





sovereigns, 1 half sovereign; 4 half-crowns the monies of Arthur Campbell, a student in the dwelling of Rev. Robert Lynam for whom Jane had been working for 6 weeks until she gave notice to quit that day. From evidence it appears that Jane was residing at No. 8 Ranelagh Street which from testimony of Jane, was her brother's house. She was tried for Larceny on the 9 December 1830 at the Old Bailey Assizes London. On the 10

December 1830 Jane was found Guilty and sentenced Death but this was changed to transportation for

life. Age given at time of conviction was 25.

Following her sentence Jane was sent to a hulk in Woolwich where she remained until on the 11 June 1831, she departed Woolwich, London on the Mary III for Van Diemen's Lane (Tasmania)



On arrival in Van Diemen's Land, Jane was assigned to William Archer Snr at his two-storey house situate on 420 hectares of land at Longford a town

in the northern midlands of

Tasmania. William called the house "Brickendon" after a village near his birthplace in Hertfordshire. (Wikipedia)

On the 10 June 1833 at St John's Church, Launceston (Wikimedia)Jane Morris, Convict married William Titmouse. (William himself arrived in



to

Van Diemen's Land as a Convict in 1815). William was a Brickmaker and a Dealer in land in Launceston.

Jane Titmus received a Ticket of Leave on 27th March 1839 and her Conditional Pardon on 14 April 1841.

Jane first appeared in local Launceston Newspapers on 1 March 1843 with "threat to assault". Next mention was on 31 March 1843 when she along with her husband, William Titmus and William Morris (her relation) were

charged with conspiracy for selling

fictitious land.

From then on Jane was to appear some 27 times in Launceston Newspapers. When I read some of the articles, it brought a smile to my face. I liked my 3rd Great Grandmother. Was very spirited and was not afraid to stand her around if needed.

I thought I would include a few of these articles as follows:

In the Cornwall Chronicle (Launceston) Wednesday 9 September 1846 the following was found on Jane Titmus:

"Friday".... Mrs Jane Titmus was fined five shillings for making use of obscene language,

which appears to have been directed towards one of the Justices, who were present when her application for license was refused. She said she had no doubt she had spoken harshly, but here was her eldest daughter (introducing her to the Bench) who would certify that there was nothing so very bad in what she said. The Captain certainly had made some observations respecting her, which was very injurious to a woman of her standing in society... she humbly begged their worships pardons, and could assure them that she never wished or intended to ridicule a magistrate. During the time she was exercising her volubility, a second information was laid against her... and immediately she set foot outside the door, she was served with a summons. A Lady Macbeth could not have presented a more striking figure that did Mrs T when she returned, clutching the obnoxious document with a spiteful grasp – Mrs Siddons would (had it been possible for her to witness it) have envied the magnificent attitude and sublime air, with which she again advanced to the bar. The Bench was struck mute, the Clerk paralysed... the Constable awed, and the spectators held their breath with fearful expectation. After a few seconds of profound silence... the heroine found her voice, which acted like an electric shock on the dormant senses of the stricken Clerk ... being completely roused ... he demanded if she acknowledged the charge contained in the official paper in her hand... being thus checked at the commencement of what was no doubt intruded to be a most eloquent and impressive address ... her oratorical impulse was annihilated, and she pleaded guilty with that sweet and mild manner, for which she is so famed – Fined five shillings and costs".

In the Cornwall Chronicle (Launceston) Saturday 27 January 1849 under Police Report, Friday the following was mentioned "Constable George

Smith had the honor of introducing the celebrated Jane Titmus. It appeared that the offender who had very recently left the "Establishment" in Paterson Street, where she had been residing for several months was probably overjoyed in regaining the sweets of liberty...... But the pleasure of Jane's liberty was not eternal, for her peculiar buoyancy of spirit attracted the notice of an "auld acquaintance" who politely escorted her to the watch houses. Jane, after the usual promises of amendment to his worship, paid the customary fine – ten shillings – rejoined her female companions, who no doubt fervently prayed for "the good estate of the constabulary".....

In The Cornwall Chronicle on 14 July 1847 "Jane Titmus, well known Pest of St Giles was yesterday committed for trial for stealing and pawning a coat..."

In the Launceston Examiner Saturday 25 March 1848....

"ASSAULT – the Notorious Mrs Titmus was released from gaol a few days ago and a warrant has again been issued for her apprehension upon charge of assault. On Thursday whilst under the influence she entered Mrs Brady's house in Paterson Street and in a fit of frenzy struck Mrs Brady a violent blow on head with a log of wood."

The newspapers often described Jane Titmus in colourful terms e.g., "that notorious woman"; "eccentric and distinguished individual"; "well known Pest of St Giles" to name a few.

On 19 August 1853 Jane Titmus was "convicted of stealing a chair the property of John Murphy and as the giving an account of her previous good character and honesty recommended her to mercy, she was sentenced to be imprisoned for 12 months"

In the Cornwall Chronicle on 28 June 1854 and Launceston Examiner on Tuesday 4 July 1854 the following Advertisement was found:

"The Public are hereby cautioned not to give credit to my wife, Jane Titmus. She is having absented herself from home and my protection without any provocation.

W. Titmus (dated 28 June 1854 and 3 July 1854 respectively)

One of the last entries was in The Cornwall Chronicle on Wednesday 19 July 1854....

"SUDDEN DEATH.... Jane Titmus, a well-known character in this town, expired suddenly at her residence in Brisbane Street on Monday Night last. An Inquest will sit on body this day".

The Inquest found that Jane died "by visitation of God to wit; of Apoplexy bought on by the intemperance of the said Jane Titmus and not by any violent means whatsoever to the knowledge of those present.

Jane "Titmouse" was buried on the 20^{th of} July 1854 at Cypress Street Burial Ground Launceston. Jane was survived by her husband, William and seven (7) children. ... ❖



WHEN THERE'S A WILL...

Lynda Smith LM2.

Wast mill

I have discovered a branch of the family that actually lodged wills and had property to pass on. These wills are quite lengthy and full of archaic legal jargon, but they contain some vital clues and verifications that have proved to be invaluable in completing this side of the tree.

The first will dates back to the late 18th century. A man called Benjamin JOSEY married a Mary WEBB in 1777 and died in 1816. He was a successful wheelwright, living in Risley Common, in Heckfield, in an area of England where county borders and names changed over time. Heckfield is a border town, sometimes in Hampshire or Southampton and it is very close to Swallowfield in Berkshire. You would think that Benjamin JOSEY would be a fairly unusual name, but there are others born in the same county, about the same time. It has taken many years to sort these people out.

Many years ago, fellow researcher had this will transcribed by someone in England. Benjamin goes into great details about the distribution of furniture, livestock, his houses and his business. Initially, he leaves everything to his 'beloved wife Mary' then six months after her death, everything was to be distributed amongst his children. In the process he outlines the makeup of his family- first mentioning unmarried daughter Mary JOSEY who was left a house, his wheelwright shop, other household goods and a cow. Another unmarried daughter Ann was given a cottage, some household goods and his son Benjamin junior gets a blacksmith's shop, tools, a pig and some rental properties. He is to share the rental of these with his sister Mary. After his death, his son Benjamin was to run the businesses and care for his mother. Another son, John gets another wheelwright's shop, a house and grounds. Anything else after the death of his wife is to be split 4 ways. One of his children, Sophia, does not get a mention, presumably as she had married a successful man, John BROWN, master coach builder in 1806.

Sophia's children did benefit from the estate of her brother, John JOSEY who died without issue. He had married a Rebecca ROGERS in 1809. She died in 1841 and he died late in 1842. His will is quite lengthy and has not been transcribed. It runs to four tightly handwritten pages. From what I can read, John had considerable wealth to distribute. He mentions his brother Benjamin JOSEY [junior] and his two children, Benjamin John JOSEY and Catherine Mary [Kitty] JOSEY. Kitty is my ancestor. He then gave married names to his sisters- Ann HILL, Mary WEBB and Sophia BROWN. He also leaves goods and money to his wife's family, the ROGERS, including some of his nieces and nephews.

His executors are given a big task that extends some years as many of the benefactors had to attain the age of 21 before gaining their legacy. His niece Mary Ann ROGERS was given two tenement houses in Alfred St Reading, 'for her own use and benefit', and all other household goods from his main dwelling, as well as £300. She is also one of the executors, so he must have had great faith in her abilities. In comparison, another niece, Rebecca LAWRENCE nee ROGERS was just given a mahogany tea table.

Nephew Benjamin John JOSEY was to get a silver watch when he turned 16, the trustees to invest £100 and the interest be paid to brother Ben until his two children reach their majority and they then get half each. He also gave his sisters Mary, Ann and his brother Ben 19 guineas each. His nephew John BROWN, eldest son of his sister Sophia BROWN was given £5, his niece Lydia, the wife of Charles BAKER, oldest child of Sophia BROWN and a former husband was given £10 'to be paid into her own hands'. I did not know about Lydia before this. The Wesleyan Sunday school in Reading was given £5. All the family have Non-Conformist baptisms, so that made sense. He then goes into great detail giving his trustees money to invest to assist his brother in law James ROGERS, but under no circumstances was he to be given 'any

controlling or alienable right or interest in or to the annuity.' It seems James ROGERS may have had problems hanging onto money in the past! I found a misdemeanour listing for a James ROGERS in the Reading Court, having been accused of fraud. He was acquitted at this time, so maybe his brother in law already had his measure back in 1842.

He then states that the following relatives are to share in the remains of his estate, which included more houses. These included: Ann JONES nee

BROWN [having married in 1833], George BROWN, Elizabeth BROWN, Sophia BROWN, Caroline BROWN, Joshua BROWN, Emma BROWN and Mary BROWN. The eldest nephew, John BROWN junior was probably expected to inherit his father's estate.

John then details how he wants his funeral done, down to choice of undertaker, stonemason and location of his burial [in



Swallowfield, Berks]. He was a very organised man and I thank him for his gifts to his extended family. I used this information to confirm the full

family of Sophia JOSEY, her two marriages and the fate of all ten of her children, all details I did not have before.

James ROGERS died in 1856, having lodged a two page will in 1855. He was then the owner of the George and Dragon Inn, Church St. Swallowfield. His will mentions provisions for his wife Elizabeth and his 'presumed' son Joseph, born to Elizabeth before their marriage. Annoyingly, he then goes on to generalise about any children of his that may survive him, without actually naming them! Mary Ann and Joseph are the only children living with him in the 1851 census when he was a 'waggon master' rather than an Innkeeper. The Inn exists today and is a heritage listed building. Its website says that the building was once a coach

John BROWN senior died in 1855, leaving a very detailed will of nearly seven handwritten pages.

He left his wife Sophia [JOSEY] a number of houses and their rents. His daughter Ann, wife of George JONES was given £300 for her own use. His son John was given a house and work premises at Eversley that

would then pass on to his son William. His son George was given the main coach building business and existing stock and an investment of £1000, His son Joshua initially was promised £500 and a life insurance policy but a codicil reduced his money to £100, with the other £400 being split between his daughters. I wonder what Joshua did to upset his father? He left instructions that his 5 unmarried daughters [Elizabeth, Sophia, Caroline, Emma and Mary] be paid regular dividends from his other investments. If any of his children had passed away by the time of their inheritance, then this should go to their issue. He had three trustees administer all of his bequests.

Most of Sophia's daughters did not marry. According to Census records, three of them [Sophia 1815, Caroline 1817 and Mary 1820] lived together, 'on their own means' for over forty years. I haven't found conclusive

evidence of Elizabeth's life after 1851 [still living with parents, aged 40] and Emma, born 1818 who may have ended her days in an upper class mental asylum. Both Caroline and Sophia died in 1895 and they both left their estates to their youngest sister Mary. In all, she inherited over £250. Mary passed away in 1903 and left an estate of nearly £1000, to be divided between two nephews- William BROWN, eldest son of her oldest brother John, and John Thomas BROWN, only son of her brother George.

Ann BROWN b 1809 married George Vicars JONES in 1833 and they had three children: Elizabeth 1834, Anne 1837 and William Restall in 1840. George was a successful market gardener and left her well provided for when he died in 1884. Ann JONES nee BROWN lasted until 1909, still 'living on her own means'. She was 3 months short of making it to 100. In 1878, her daughter Anne JONES married, when she was 40, to George PHIPPEN, a widower with three teenage children. George was an extremely successful nurseryman, florist and seller of seeds. When he died, at the young age of 50, his businesses were sold and his estate went to Anne. It was valued at over £3088! By then, his three children were adults with lives of their own. She did the right thing when she died in 1924 and left everything to George's eldest daughter's family.

At first I did not understand Anne PHIPPEN's probate record, as it stated that everything was left to one Henry Thomas PUGH, Director of Education. I thought she must have wanted to support local education in some way. I could not work this out until I realised that George PHIPPEN's daughter Elizabeth had married said Henry PUGH in 1885 and together they ran a private school. The estate had grown to £4886 by then - a very tidy sum. When Elizabeth PUGH died in 1946, the estate worth had been reduced to £2000.

I don't know if it was a result of not being a beneficiary, but William Restall JONES ended up creating a different legal document. He married Martha FEWSTER in 1861 when he was 20. He married the daughter of his employer, who was a large land owner. William and Martha had five children from 1862-1870. In 1872 Martha JONES applied for a divorce. This was a rare and expensive thing to do at this time. The statements she makes paint a terrible picture of long term domestic abuse, adultery and the effects of a sexually transmitted disease. In 1873, a Decree Nisi was awarded to Martha and she kept custody of her children- another rare decision. William's troubled life was cut short when he died in 1873, at age 32. Without purchasing his death certificate, I can only surmise that his acquired disease caught up with him, or that he ended his own life. I don't believe he left a valid will and his meagre estate valued at less than £100 went to Martha via administration.

All in all, it has been a very fruitful line of research.

ANZACS BUILT IT: THE GREAT OCEAN ROAD 90 YEARS ON

Great Ocean Road & Parks Authority - Published on 24 April 2023

Tomorrow, we remember and honour the men and women who served and sacrificed in wars, conflicts and peacekeeping operations.

The spirit of Anzac is about courage, mateship, endurance and loyalty. And these values are quite literally cemented in the road our work at the Authority centres around.

The Great Ocean Road was built by returned soldiers between 1919 and 1932 as a legacy piece to their fallen comrades and it's often referred to as the world's largest war memorial.

Constructed using only picks, shovels and explosives, rugged terrain and harsh weather was just the beginning of the challenges faced along the way—they also had to cope with the physical and mental scars of war.

Officially opened in 1932 with a convoy of 40 cars carrying tourists to Lorne, today the Great Ocean Road carries over two million visitors each year. To commemorate its 90th anniversary, we spoke with members of the Torquay RSL and learnt more about this remarkable piece of history from their unique perspectives.

MELBOURNE CUP AWARDED FOR A FROG RACE

Meeting run by the Adam Park Racing Club, Singapore, 1942

This improvised trophy cup is made of two parts of a coconut shell joined together in the centre by a nut and bolt. Each side of the cup has a curved metal handle attached by two small nuts and bolts. The cup has an aluminium plate rivetted to it engraved with laurel leaves and '1942. FROG RACE MEETING (POW) MELBOURNE CUP SINGAPORE.' The base of the cup has another engraved aluminium plate rivetted to it that reads, 'WON BY TRIGGERMAN 3-11-42 OWNER CAPT W. DIXON'.



A Melbourne Cup meet for frog racing was held by Australian prisoners of war at the Adam Park Racing Club at Sime Road prisoner of war camp on 3 November 1942. A frog named Triggerman won the event. He was owned by VX46525 Captain William Dixon, of the Australian Army Service Corps. Dixon was born in Melbourne in 1896. He served in the First World War and enlisted for service again on 12 July 1940. He was discharged on 8 November 1946.

Another POW, VX37222 Private James Purtill, later described frog racing in Singapore as 'this popular amusement did not last long, but while it was going it drew ... the whole camp in fact to the frog racing courses...The idea was simple. You chalked a big ring on the asphalt, put your candidates (suitably marked with coloured rags, papers etc.) in a box in the middle and when the betting was finished the caller lifted the box, and a dozen or so scared looking frogs hesitated a few seconds and then commenced hopping. First over the line, of course, won. The sweepstakes were small but the betting was in many cases heavy ...the crowds at the courses were two deep and money changed hands in big quantites'. According to Purtill all the frogs were given names and pedigrees, e.g. 'Gordon Bennett, out of Singapore by Capitulation'.





IN OUR LIBRARY PICTORIAL HISTORY OF WYONG — "UNCLE GEORGE" OF BLUE GUM FLAT

One of the most popular and best. known pioneers on the Central Coast was George Henry Edward



Taylor (known as 'Uncle George'), who was born at Punchbowl, January 1840, and come with his parents to settle at Blue Gum Flat soon afterwards.

He was a brother of Richard Brawn Taylor.

He became a schoolmaster. and married a teacher who was named Elizabeth Bristowe, who was the first teacher appointed to the Blue Gum Flat when it was opened 10 October, 1863. Before that, she had taught privately in the Stinson home at Yarramalong.

In the middle 1860s she was teaching at Cooranbong at the same time as he was in charge of the school at Mandalong some miles away.

George was very sports minded and with his lifelong friend, John Robley. organised the first cricket matches played on the Central Coast.

He was an amateur jockey, who rode at the local race meetings at Gosford and Blue Gum Flat, John Robley wrote of him his memoirs: "the principal jockey was George Taylor and a very good one too."

A horse lover, he delighted in breaking in horses and riding buckjumpers at show rodeos just the fun of it.

He was closely associated with John Robley and William Baldwin in organising the Brisbane Water District Pioneers' Association.

He lived to be a Very old man. His last years were spent at The Entrance where he lived at Bayview Guest House, established by his niece, Mrs "Delly" Denning,

To fill in time, he used to cut swamp oak firewood for the fuel stoves and the fireplaces there.



again use our access road and carpark *The Cottage* has one basic accessible toilet?






VALÉ HARRY JOHNSTON-LORD MEMBER #504
