Milestones: John Nichols Family Society Celebrates 40 Years (Part 2)

Last issue we highlighted how the John Nichols Family Society started, remembered the family reunions, and celebrated the publication of the John Nichols book and the beginnings of the Society's *Newsletter*. This issue we look at the many other achievements of the Society over 40 years and acknowledge the contributions of its members.

Highlights from the Newsletter

The *John Nichols Family Society Newsletter* has featured research on all the family lines of our large family. In 1984 Kaye Purnell reported that there were 85 known grandchildren of John Nichols and Ann Pugh making ours certainly one of the largest First Fleet families.¹ In 1998 Pearl Loller noted there were 16 great-grandchildren still living in Martha's line and Ken Brown wrote of the passing of Bernice Elliot, one of the great-grandchildren in the John Pugh Nichols line.²

Early newsletters reported the 'Life and Times of John and Ann Nichols'. Research on John Nichols appeared in 1992 relating to the Leominster district. Details of John Nichols' trial at the Old Bailey were given in 1997 together with research commissioned by the Committee⁵. On 21 July 1991 Committee members joined the Prospect Trust Group in celebrating the 200th Anniversary of the 'First Land Grants' at Prospect Hill. Of course, this included the grant made to our own John Nichols. Ann and the village of Lyonshall were shown in May 1990.

Ken Brown's detailed research on Ann Pugh and her origins in the village of Lyonshall was reported in 2001.⁷ Other research on Ann appeared in 1992.⁸ More information on John Nichols' origins in the village of Leominster were reported in 2007 by Aileen Fergusson.⁹

There have also been many stories of cemeteries, headstones and burials. Memorials to John Nichols and Ann Pugh at both Devonshire Street Cemetery and Botany Cemetery have featured. Peter Nichols arranged for a memorial to Thomas and Martha Nichols at Daylesford Cemetery in Victoria in 2007. Of course many of the stories of burials came from the Kinsela family of undertakers!

The John Nichols Family Society Newsletter has shared many family stories over the years. Many are tales of courage in raising families in difficult times and in serving in times of war. In December 1995 the Society published a special issue 'John Nichols Family Society Remembers' which recorded the names of those family members who served in conflicts from the Sudan War through to the Vietnam War along with many of their stories. One of those mentioned who stands out in our newsletters is Paterson Clarence (Pat) Hughes b.1917 d.1940), the son of Percival and Caroline Hughes nee Vennel. He was an Australian who served with the Royal Air Force as a Flight Lieutenant. He lost his life during the Battle of Britain and was posthumously awarded the Distinguished Flying Cross. He is buried at Sutton, Hull in England where his life is still commemorated. Further details of his life and death were given in later issues.

Other stories have revealed the many talents and interests of our family, both present and past.

Trevor Stewart has written a number of poems on the family.¹² Valerie Windley also wrote a poem.¹³ Other family poets have been Percival Clarence Hughes¹⁴ and Mary Locke.¹⁵

Who would have thought that a John Nichols descendant would have raised a lion cub in the middle of London? Well John Rendall did!

Or who would have thought that Joseph John Pearce (b.1919 d.1969) would have contested the America's Cup with Dame Pattie in 1967!

Members have also shared their personal memories of events such as the Sydney Olympics in 2000 and various generations' memories of walking across the Sydney Harbour Bridge at its opening in 1932 and up to its 75th anniversary in 2007.¹⁶

A number of our family members have been honoured for their achievements.

In the 1996 Olympic Games **Rechelle Hawkes**, a Thomas Nichols descendant, won Gold as the Captain of the Hockeyroos, the Australian hockey team.

In 2006 **Allen Findlay** (Windley family) received the Medal of the Order of Australia for 'services to the community through aged care, educational and service organisations'.

In 2001 **Glennis Manuel** (Charles Nichols family) received the Order of Australia Medal in the General Division 'for service to the establishment of the Interstitial Cystitis Support Group in Sydney and assisting the establishment of similar support groups around Australia.'

In December 2012 we congratulated **Stephanie Rice** on representing Australia in swimming. Stephanie, GGGGG Granddaughter of Sophia Nichols and Alexander Philp was one of Australia's most successful Olympians and one of the most recognised athletes in the country.

Islay Lee, whose 3rd great grandparents were Sophia Nichols and Alexander Phelps (Philp), is the partner of Em Blereau who highlighted to us that he was a fifteen times national champion (sculling and sweep oar) and represented Australia in two Olympics. Most of his youth he trained on the Clarence River.

In May 2014 we celebrated our 30 year anniversary, and consolidated many genealogy sites connected to John & Ann into a list to help descendants plan a journey of discovery

We have highlighted the great service to Australia and Australians by descendants who are either Nurses, Policemen, and World War veterans &/or POW's

Research has continued into the origins of Ann Pugh, but without a lot of success

Research has been given a large boost with the development of DNA testing and its availability to everyone. We have written articles about its use in identifying cousins as well as going further back to try and find the origins of Ann Pugh and the families of the siblings of John Nichols

In 2015 we commemorated the centenary of the Gallipoli landing by retelling the stories of cousins who were there.

We updated the JNFS Constitution to meet the guidelines laid down by the Department of Fair Trading

Back copies of newsletters 10-70 were made available on USB for members to purchase

With the pandemic of Covid 19, we were unable to get the Newsletter printed and were forced to email a digital copy to members. As pandemic restrictions eased, many members elected to stay with the emailed version.

We continue our Policeman theme from Newsletter No 79 – Part 5.

Eric Joseph Walsh (1904 – 1988) and his brother Joseph Gerarde Walsh (1914-1984) Policemen, who descend through the Amelia line.

Eric Joseph Walsh was born on the 21st November 1904, in New Zealand, the 3rd child of Martha Ann (nee Newitt) and James Joseph Walsh. Eric's parents had relocated from Tasmania after their wedding in 1901. Recapping from the last newsletter, Eric came to New South Wales and by 1924 was residing in Dorrigo, this is evidenced by the 'Valedictory Dinner' held in his honour on behalf of the Football League' on the 13th December 1924. Eric was transferring to Casino to police, as he had obtained a position working there. Eric's younger brother Joseph Gerard Walsh (1914-1984) also became a policeman and their stories and photographs are featured below, compiled by their nephew Patrick McKenna (who was also a Policeman in New Zealand).

I never met my Uncle Eric, I grew up in Auckland and he had long since moved to Australia. What I do know of him is from my Uncle Jack's (John Walsh) family story which he was writing in 2008. Uncle Jack passed away in 2011. The following is from my Uncle Jack's memoirs:

"I know very little of Eric's life before he left for Australia in about 1927. One instance I recall is his placing some small chocolate bars on the very top of a tall wardrobe stationed in the hallway of the family home at 8 Rendall Place Auckland. They were for Patricia and I. He was watched by myself and twin sister Pat at that time, we were four years of age.

Eric was athletic and performed gymnastics and is pictured here as the 'Anchor-man in a gymnastic pyramid' standing centre in 1925, at Kohimarama Beach, in Auckland. He drove in a bus fleet named Keys around our waterfront drive from downtown to St Heliers township and return for some years before leaving for Australia. Eric married Mary Florence Sullivan (1907-1999) in 1928, at Paddington, in Sydney. He wrote home occasionally and also sent photos. Martha, my Mum and James our Dad made a trip to Sydney with Irene on the 'Niagara' with the intent of seeing Eric. Irene, then at 18 years of age was going to work at David



Jones in Sydney. They arrived after three days steaming at Sydney and Mum and Dad enjoyed the trip and went to Sydney again in 1933 on the Number 7 Matson Liner SS Mariposa the date of departure was February 27 1933. They revisited relatives and friends, saw the new Sydney Harbour Bridge on disembarking at Sydney. Dad recalled seeing Eric training in a Police gymnasium in Sydney, climbing a rope



to the gym ceiling. Eric had joined the New South Wales Police Force and over the years was on the beat on Sydney streets with the Water Police on the harbour and then on motorcycles. (Left: Eric C1933) We next met up with him when Martha took my twin Patricia and I to Australia in the Christmas/New Year holidays of 1938/39. My brother Joseph already in Sydney, arranged the meeting and we met at Joseph and Joyce's home in Hornsby and at places such as Watson's Bay and Sydney CBD. It was great to make contact again. I am aware that Eric lived with wife Pat at Bondi at one stage where he used to climb up and down the cliffs with his Alsatian dog for a swim.

My brother Joseph and his wife Joyce met up with Eric and Pat several times before Eric and Pat moved north to Palm Beach and other places before choosing to settle in Old Bonalbo. From that time possibly in the 1980s, Joseph lost contact with them. I made enquiries by writing to the postmaster there. She kindly informed me he had had heart surgery and was still living in the District. Eric and Pat were not letter writers. An infrequent letter to Mum and Dad was all you could expect and they preferred to live in out of the way places, not cities. Towards the end of their lives they lived in Bean Creek Old Bonalbo. Rosalie and I and lifelong friends Maree and Tom Sheehan visited Australia in March 1988 at the time of the Expo in Brisbane, and managed a visit to Casino not far from Old Bonalbo. Eric had died of bleeding ulcers on 20th March 1988, according to a letter from his wife Pat and dated 3rd May 1988. When we were in Casino we contacted Pat by phone and talked with her. She did not encourage a visit from us and was devastated. After we came back from holiday we had a letter from Pat's half sister received on 12th February 1999 saying Pat had died on 8th January 1999 at 4:20pm. Both Eric and Pat are buried in the Casino Lawn Cemetery after Catholic funerals. They left no issue. They were best mates and lived an 'Australian lifestyle'. In the early 1980's Joe and Joyce tried hard to make contact with Eric and Pat to no avail. The nomads did like to shun even family contact. We were left with happy memories of both of them despite their wanderings.

Joseph Gerarde Walsh (25.01.1914 – 25.04.1984)

I met my Uncle 'Joe' only once when I visited him in Gosford in 1980. I travelled there by train from Sydney where I was honeymooning from Auckland with my then wife Jane. I remember that his property had beautiful gardens and inside his house were many paintings that he had done. He was very artistic and I recall he and my mother shared that love of botany and art as my mother was a floral artist. I remember as a child a beautifully carved wooden ashtray that stood about one metre tall in our drawing room; it was of a tree with a young woman standing beside it holding a towel draped to preserve her modesty but it looked like a scene where she had been swimming in a lake or river naked and just emerged, it was carved but then somehow smoothed and polished to a high degree. This had been done by Uncle Joe; since my mother's death I don't know what happened to that piece but it was a striking example of his artistic talent. On my visit he was very kind to me and took us around the area before we enjoyed his and his wife Joyce's hospitality back at their home. I was aware that he had been in the sign-writing business for a significant part of his life in Gosford and it was only during the time I was researching family history with Uncle Jack (John Walsh, his younger brother) that I learned he had been in the New Zealand Police. Much like Uncle Jack my Uncle Joe struck me as a very kind man and they were both very good role models to have as a youngster growing up. Uncle Jack had a copy of one of Uncle Joe's Police notebooks which made interesting reading of what a beat cop in Wellington might encounter in the 1930's. It was the same style as I was using when first a beat cop in Auckland in the 1980's. Uncle Joe had a daughter Maureen who worked in Rome as a secretary in the Australian Embassy and then settled in Italy with quite a well-known artist Tonino Caputo. Joe and Joyce also had two sons Barry and Dennis of whom I know very little. The following is from my Uncle Jack's memoirs written in 2008:


"Joseph Gerarde Walsh – written by his younger brother Uncle John 'Jack' Walsh's 2008 story)

He was a handsome child and the apple of his mother's eye. His mother Martha recalls him as a child sketching the fowls in the coup next door from our sitting room windows at 8 Rendall Place, Auckland! At age 13 he did a nativity scene in pastels and we have this framed courtesy of our son Michael and in our possession at 16 Matai Road. This drawing talent blossomed at secondary school during the years 1927 to 1929 at Sacred Heart College then situated in Richmond Road Grey Lynn and where he topped his class in drawing in the upper forms. He was a good scholar, applied himself well but didn't enjoy athletics or football. He was faithful to Catholic worship and was an altar boy at St Benedict's.

His school leaving coincided with the onset of the depression. He had to leave home for a job on a farm in the Coromandel District for 10 shillings a week and keep, and loathed the mud and filth. He eventually came

back to Auckland and undertook gardening duties with the Auckland City Council and used this talent at the Auckland Domain, the Monte Cecilia garden in the convent grounds and the Mater Hospital in Epsom. His talent in gardening and landscape was put to good use at 8 Rendall Place and the grounds were a picture. He occupied a 'bach build' for his Dad on the property where he slept and used it as his own.

About 1934 he signed up to become a Policeman and trained at Trentham. He graduated and had patrol duties in Wellington City. After a time he didn't fancy policing as a career and he resigned. He came back to Auckland and within a short time departed for Sydney in 1936. Photographs he sent home were views of Sydney, Brisbane and Albury. Joe enjoyed a holiday, swimming a lot, sunbathing and seeing some of Australia and his picture taken C 1934, appears to show that. He always maintained good health and we next met up with him in Sydney at Christmas 1938, when Martha and my twin Patricia and I came on a visit for 3 weeks. When Joe first arrived in Sydney he met up with his older brother Eric who was in



the Police Force and spent time with him and his wife Patricia. Patricia was also employed in Sydney. He next set up a flower business growing blooms for the Sydney market.




He did this for a short time but found that water shortages and other difficulties meant he had to change his occupation. Photograph left depicts Eric's wife Mary Florence (nee Sullivan) Walsh and her brother-in-law Joseph 'Joe' Walsh C 1938.

'Joe' married a Sydney girl Joyce Cotterill from Waitara and started a family- Maureen their first child was born in 1942.

Once Joe got married he set about getting a house built on a section in Hornsby, North of Sydney. At one stage in the building programme he fired the builders and finished the task himself. It was an attractive little property and we visited there in January 1939 and Eric came along on his Police bike too. Joe did Army service in Australia and

due to his experience in Police work he was drafted into the Military Police. Photograph right: 'Joe' and daughter Maureen taken in 1944.

A talent for wood sculpture resurfaced when in Auckland he carved a racehorse in motion out of wood blocks. He achieved this by sketching on all six sides and then whittled away to produce life like figures. Dad and he had gone to the Ellerslie races to watch the favourites powering around the course and he completed models of Peter Pan and Star Stranger, both champion racehorses of the time.

Joe enjoyed swimming and especially gardening, particularly his own home in Terrigal on the N.S.W. Central Coast. He had a real gift for plant culture, garden design and structure and was much respected in the community. He established a successful sign-writing business which he eventually operated out of Gosford. He battled cancer and had ray treatment which made him nauseous. He still maintained an interest in gardening at his home and photographs we have show its beauty and grandeur.

His daughter Maureen at the time of writing still lives out of Rome as far as I know and has two grown up daughters. Her partner Mario Caputo (Tonino Caputo) is a professional artist/painter who has exhibited in America, Italy and Australia and she assisted him to stage his exhibitions.

Barry and Dennis, Joe's two sons are very good artists I have been told. I am not aware of their status. Joe and Joyce visited New Zealand several times when Martha was alive. Joe stayed in Auckland when Martha was at The Mater Hospital in their care. He took her out in the wheelchair when calling there in 1975 and 1980. Martha passed away on 30 August 1981. Joe succumbed to cancer on the 25th April 1984, aged 70, and his wife Joyce passed away on the 3rd May 2004, aged 86 and they were buried in the Wamberal Cemetery on the Central Coast. Their headstone appears below.

John Nichols Family Society (JNFS) - Thanks Carole Brown Committee Member from 2008 to 2023, and Past Convenor from 2008 to 2013

Carole is retiring from Committee, having been very closely involved with JNFS from the time her father William "Bill" Durrant (1912-2005) became a founding member of the Society back in 1983/84. More formally, at the Committee meeting on 1st August 2008 Carole was invited to join the Committee and immediately take on the role of Convenor. Computers were still in the 'cut and paste' mode and members were not as "tech savvy" as they are today. Photographs didn't always look their best and margins were not always the same.

From day one Carole was faced with many challenges and rose to the occasion with professionalism and minimum fuss. **Privacy issues** were coming to the fore, and at the committee meeting in August 2008, Carole presided over the decision to no longer publish members' email addresses in the Newsletters.

For comparison with today, the December 2008 Newsletter (15 years ago) consisted of 36 pages and cost \$12. Money was paid by 'Cheque' or 'Postal Note'. Perhaps some younger members have never heard of either? The society held 5,096 photographs and 1452 documents.

The feature article: The Thomas Line, by Helen Alderman was available for purchase for \$10.

Almost immediately Carole was faced with **personnel changes**. In February 2009 Lilian Magill accepted an invitation to join the committee. Webmaster Rodney Nichols retired after doing a wonderful job and his shoes were filled by Bruce Markey who has held the role ever since. Sue Downes took on the role of Ann Pugh Nichols / John Kellick Family Coordinator

Celebration of the 25th Anniversary of John Nichols Family Society (1984-2009) was another task facing Carole early in her tenure as Convenor. The cover of the May 2009 Newsletter, was designed by Joy Marden (Philp family) and the family tree on the cover has twelve branches representing John & Ann's children and one hundred and six leaves representing their grandchildren.

Carole's compassionate nature became evident in May 2009 when the Society **donated \$300 to Red Cross BushFire Appeal** stipulating the money be used for food and counselling. This followed the dreadful Victorian Bushfires where John Broadbear, a member of JNFS lost his home and all his memorabilia.

Nomination by each Family Coordinator, of six certificates / transcripts of BDM certificates for purchase by JNFS, was introduced by Carole and Committee. Copies of these purchases are then FREE to members on their family line.



Carole & Committee decided a **new position**, **Membership Secretary**, was needed in December 2009. In May 2010, with membership numbers growing, this position was filled by Lilian Magill. This task was previously carried out under the umbrella of the Treasurer.

In May 2011, Carole announced that she would oversee **the organisation of the Daylesford Reunion**, a major task for any Convenor. Again showing her compassion, Carole & JNFS donated \$300 to the Queensland flood relief and offered to help/replace lost JN memorabilia. At that time, JNFS collections were growing and the Society held 5,483 photographs and 1652 BDM certificates / transcripts.

The First Reunion Outside of NSW was held at Daylesford Victoria on 2nd and 3rd October 2011. Over 250 people attended on the Sunday and 104 people attended the dinner. Carole introduced several new innovations for our reunions including *The First Reunion Dinner*, and the engagement of a professional photographer. This resulted in fabulous family line photos with each person named as well as a 'big' group photo. In 2011 Carole again presided over several personnel changes including Dorothy Mulholland retiring as Treasurer (2008-2011). Sue Downes became both Secretary and Treasurer.


Over the years descendants of John and Ann have had over 30 poems published in the newsletters. Carole **suggested they be compiled into a poem book**. So in December 2012, members were asked to send in their poems and the Poetry Book was to be in Memory of John Nichols First Fleeter and his wife Ann nee Pugh to commemorate the 225th Anniversary of the First Fleet Landing. A copy of the book is retained for JNFS Archives, and copies were given to the National Library of Australia, State & local libraries and many Genealogy Societies. A copy was also given to Jerangle Public School, who named their school library after Percival Clarence (Percy) Hughes (1874-1970) great-grandson of John & Ann Nichols.

In May 2013 Society produced the book containing ninety poems written by descendants of John and Ann Nichols and their family. The earliest poem was written in 1849. The book is called: "Without Rhyme or Reason", and a successful book launch was held on Sunday 30th June 2013 at Fox Hills Golf Club on land previously owned by John Nichols.

"Without Rhyme or Reason" received a very favourable response and many books were sold on the day. After the formalities and lunch, many folks took the opportunity

to visit the reserve at Samuel Way, Pemulwuy, Prospect to see the street named after our John. 'Nicholls Way' is near a street called Driftway Drive.

This is the third of several articles about the children of Thomas & Martha Nichols. The articles will focus more on the traditional historical events and dates, than some articles in the past. Articles have been written in the past about isolated sections of this family, firstly in December 2007 by Peter Hoffman, then December 2011 by Alan Palfrey, then May 2017 by Peter Nichols, and most recently in December 2021 by Ann Wells.

Thomas & Martha's 3rd child, John Nichols, was born on 8 November 1856 at Ballarat, Vic. He was a bushman, an asthmatic and died of pneumonia on 26 August 1877 at Werribee, Vic, at age 20 and was buried in the Church of England Cemetery, Daylesford, Vic. His Mother, Martha nee Johnson was buried in the same grave in 1911.

Thomas & Martha's 4th child, Joseph Nichols, who was born on 27 August 1858 at Ballarat, Vic. died on 2 September 1909 at St. Vincent's Hospital, Fitzroy, Melbourne, Vic, at age 51 and was buried in the Methodist Cemetery, Daylesford, Vic. He married Elizabeth Frost, daughter of John FROST and Leah Norman, on 6 August 1883 at the Wesleyan Parsonage, Daylesford, Vic. She was born on 5 October 1860 at Bullarto, Vic. and died on 30 November 1924 at 44 Chestnut Street, Richmond, Melbourne, Vic. and was buried in the Church of England Cemetery, Daylesford, Vic.


Joseph & Elizabeth had one child (great grandchild of Thomas & Martha Nichols) He was John Thomas NICHOLS who was born on 1 October 1887 at Mirboo North, Vic. died on 6 July 1956 at Geelong, Vic. and was buried in the Church of England Eastern Cemetery, Geelong, Vic. He married Emma May Culph, daughter of John Thomas Culph and Eliza Ann Mitchell, on 16 September 1914 at the groom's residence, Sailor's Falls near Daylesford, Vic. 

She married Joseph Jackson, a Jointer, son of Horace Jackson and Lily Harris, on 25 January 1911 according to the rites of the Church of England at Daylesford, Vic. He was born on 3 March 1889 at Kidds Gully, Daylesford, Vic. and died on 2 August 1948 at the Austin Hospital, Heidelberg, Vic. and was buried in the Church of England Cemetery, Footscray, Vic. Antonio was born on 15 June 1888 at Daylesford, Vic. died on 24 Sep 1950 at Daylesford, Vic. and was buried in the Catholic Cemetery, Daylesford, Vic.

Sixthly, Henry Turvey who was born on 1 December 1897 at Bullarto, Vic. He was a Linesman in the Postmaster General's Dept. died on 10 September 1963 at Upwey, Vic. [without children] and was buried in the Baptist Cemetery, Footscray, Vic. He married Ivy May Chick, daughter of Frederick Arthur Chick and Betsy May Jewer on 6 February 1943 at Footscray, Vic.

She was born in 1903 at Burwood, Vic. died on 04 May 1961 at Upwey, Vic. and was buried in the Baptist Cemetery, Footscray, Vic. No photo found

Seventhly, James Turvey who was born on 27 August 1899 at Bullarto, Vic. and died on 5 April 1900 at Bullarto, Vic. and was buried in the Salvation Army Cemetery, Daylesford, Vic. No photo found

Eighthly, Elizabeth Ann TURVEY was born on 16 January 1901 at Daylesford, Vic. She married Albert William Scott in 1922 in Perth. He died on 22nd October 1954 and was cremated at the Karrakatta Crem, Perth, W.A. Elizabeth remained in Perth until at least 1980, She died on 21 March 1990

at St Kilda, Vic. with no children. No photo found

Ninthly, Muriel / Marion Beatrice Turvey who was born on 10 June 1904 at Daylesford, Vic. and was alive when her Father died in 1913. Nothing more is known.

Thomas & Martha's 6th child, William Nichols who was born on 8 November 1862 at Ballarat, Vic. died on 26 January 1932 at Geelong, Vic, at age 69 [unmarried] and was buried in the General Cemetery, Geelong, Vic. No photo found

Thomas & Martha's 7th child, Louisa Nichols who was born on 30 November 1866 at Ballarat, Vic. died on 11 January 1942 at St. Vincent's Hospital, Fitzroy, Melbourne, Vic, at age 75 and was buried in the General Cemetery, Preston, Vic. She married John Goss, son of William John Goss and Belinda Hoey, on 26 July 1884 at the Presbyterian Manse, Daylesford, Vic. He was born in circa 1857 at Melbourne, Vic. and died on 25 April 1896 at Willunga, Adelaide, S.A.

Louisa & John had one child (great grandchild of Thomas & Martha Nichols), William Thomas Goss who was born on 3 July 1885 at Bullarto, Vic. and died of diphtheria on 10 June 1890 at Korweinguboora near Daylesford, Vic. and was buried in the Church of England Cemetery, Daylesford, Vic. No photo found

Louisa had one other child (great grandchild of Thomas & Martha Nichols), Doris Lillian Goss (father unknown) who was born on 1 December 1901 at 175 Mary Street, Richmond, Melbourne, Vic. Doris was not the informant on her mother's death certificate. [Hospital staff]. Her gravestone at Mornington Cemetery states she died 9 May 1993, and had 3 children. No photo found



Reginald Raymond Bradney aka Wildman (14th April 1896-20th July 1916)

This is a very sad story in many respects but one that has had me intrigued for many years and it began after I watched a 60 Minutes program in 2008. They were calling for people to come forward and donate their DNA to help identify 75 WW1 soldiers, who had been found in a mass grave from 1916, following the battle of Fromelles, in France. Exhumations of the bodies, and extensive testing began in 2008, to ascertain the identity of the men who had been listed as MIA, their bodies lying in a mass grave for over 90 years. One of the young soldiers was positively identified as Reginald Raymond Wildman. My mother's maiden name was 'Wildman' and her father George Negrus Wildman and family grew up on the South Coast of New South Wales in the years that Reginald and his mother Auriol were born and residing there. This is what we do know: Auriol and her baby Reginald moved into the household of John and Emma Wildman and MY grandfather George was the same age as Auriol. After a short time Auriol moved out, but the baby stayed and was raised for many years by the Wildman family. Was Reginald their grandson via one of their four sons?? A great mystery.

Auriol Agnes Bradney (photo right C 1895) was born on the 8th December 1878, at Narrandera, the 3rd of 11 children to parents John Bradney (1844-1916) and Catherine (nee Brownlow) (1851-1908). Auriol was 17 years and 4 months old when she delivered her son Reginald Raymond Bradney, born on the 14th April 1896, registered at Wollongong. No father's name appeared on the birth certificate. Auriol's father John Bradney (1844-1916) was a farmer and the family re-locate several times, probably chasing employment.



We believe the rationale behind this move was initially due to Auriol's older brother John Bradney born 29th June 1874, being successful in applying for a soldier Settlement Grant (No: 1907/33), Farm No 150 in the Parish of Cottee, near Wagga Wagga, after he returned from the Boer War. John was a Riverina Scout with the Hon. Rupert Carrington Force, shortly before the end of that conflict. John Bradney (*left C 1916*) played a huge role in his family's lives. As a child he was privately tutored at home and according to his sister Emily "growing up he understood all kinds of machinery and farming, and helped support the younger children in the family". After purchasing 'Gobbagombalin Farm' with his settlement grant monies, he enlisted for WW1 on the 9th March 1916, then aged 41 years and 9 months, his Service No 2376. John stated he was 5'9" tall, weighed 155 lbs with a fair complexion, black hair and was unmarried. After basic training in Goulburn, he

embarked on the '*Aeneas*' for Plymouth in England, disembarking on the 19th November 1916, joining the 56th Battalion. John's WW1 record states 'he marched into France on the 3rd December 1916'. According to his military file he was missing in action for several days, then pronounced dead on the 2nd April 1917, having been killed on the battlefields of France, during the campaign which pushed the German troops back to what was known as the Siegfried line. He was 42 years old. John was also the **official guardian** of <u>Reginald Raymond Wildman</u>, who worked and lived with him, and Reginald had listed his Uncle John as his N.O.K. on his attestation paperwork.

Reginald Raymond Bradney AKA Wildman (right) was born on the 14th April 1896 and it appears that he spent his youth 'with the Wildman relatives of Kiama.' His mother writes a letter to the Army and states that "he was my son, he had no nearer relatives than myself. He was illegitimate unfortunately, so that his father's name would not be necessary. Wildman was not my sons' name. It was Reginald Raymond Bradney but as he lived with people of the name Wildman, he was mostly called Reg Wildman, and when he registered for cadets some years ago he was advised to register under that name." Auriol married David Jones on the 25th September 1903 and they have six children together.

Although Reg clearly had a closer relationship with his mother when older, we have no evidence he ever lived with her; except when they both lived with the Wildman family immediately after he was born. There was contact between Reg and his mother Auriol (nee Bradney) Jones, as part of his schooling was done at Kittigra Public School, near Coolamon. Reg wrote to her whilst on active service and she



received the notification when he was killed in action as the primary NOK; John Bradney (Reg's uncle), had been killed the 2nd July 1917.

It is well documented that he spent his early years with 'his mothers' Wildman relatives, and then spent the years prior to the outbreak of WW1 residing with his 'Uncle John' Bradney on his Wagga Wagga property at Coolamon, working as a farm hand.

Reginald enlists for military service on the 30th December 1914 at Liverpool and states he is aged 18 years old and his TRUE name is Reginald Raymond Bradney but attested for the Rein 2nd Battalion as Reginald Raymond Wildman. His Service No is 1888 and he is Church of England. Reg is 5'8", weighs 126 lbs and his current address prior to enlistment was at 'Hevington,' Cottee Mail, via Coolamon N.S.W. and gives his 'Uncle John Bradney as his N.O.K. (same address). Stating that he was employed there as a Farm Hand. Coolamon is situated 40k's North-west of Wagga Wagga, and 506 k's South-west of Sydney. His entire military file is in the name of **Wildman**.

Reg is attached to the 2nd Battalion, 4th Regiment and the unit embarks Sydney on board *HMAT A8 Argyllshire* on the 10th April 1915. On the 31st May 1915 he joins the 2nd Batt and arrives at Gallipoli. The following day he is admitted to the Convalescent Camp at Cairo with influenza, but re-joins his unit on the 9th June 1916 at Gallipoli and takes part in the Battle of Lone Pine. On the 19th July he reports sick (diarrhoea) and is transferred to the 24th Casualty Clearing Station at Lemmas, re-joins Batt 29th August 1915. 18th October 1915 transferred to No 3 Aust. General Hospital with an abscess on his neck, 24th November 1915 re-joins his Batt. Reg is then transferred to the 54th Batt on the 14th February 1916. On the 8th April he falls ill with pneumonia and gastritis but is discharged back to his unit 18th April 1916.

Reg embarked Alexandria to join the British Expeditionary Force, 19th June 1916, disembarked Marseilles, France and reported missing 19/20th July 1916.

A court of enquiry was held in the Field on the 4th August 1917, pronounced fate as "killed in Action, 19-20 July 1916, in the Battle of Fleurbaix, Poziers, France.

Three witnesses are interviewed and an account of their statements follows.

"RED" "CROSS "FILE No 2940705 Statement from Private 4226 L. Hanna, B Company, 30th December 1918. "On the morning of the 20th July 1916 at Fleurbaix I was alongside him when he was shot dead by a sniper. Hit in the head (eye). We were then in Enemy's second line trench. They got in behind us into their 1st line and we were cut off. I was hit through the helmet by the same man immediately after, but not hurt. We were taken Prisoner of War about 1 hour later. His body would be left in the trench. I did not know his Christian name."


<u>2nd Witness Statement: 3511A W.D. CARR, 54th Batt. 24th Dec 1918:</u> "In the morning between 8 and 9 o'clock I saw him assisting 1909 H.W. Bilbow with a machine gun, when he was shot through the right eye either by a sniper or a machine gun bullet – not shrapnel, as he was killed instantly. It was a quickly dug trench. We were captured shortly afterwards so I know nothing as to his burial."

Third Witness Statement: 1909 Lance Corporal W.H. Billow, 13th January 1919. "He was not killed going over the trenches but after he got over in the Germans' second line on the morning of the 20th. I was standing shoulder to shoulder with him up to the moment he was killed. He was shot by a sniper from behind, the bullet passing through his head. He had been working all night with me, trying to build up the trenches. It happened at Fleurbaix – I took his paybook and his identification disc but was forced to give them up to the Germans with my own paybook."

Conclusion: Reginald Raymond Bradney/Wildman was shot at the Battle of Fromelles on the morning of the 20th July 1916 and his body remained unfound. An unmarked mass grave was discovered after excavations in 2006, and the wooden cross that he carried, pictured right, was found in his uniform pocket. With the assistance of D.N.A. provided by his half-sisters daughter Norma Staber (daughter of Alice (nee Jones) Rock, in 2008, Reg's remains were positively identified and his body finally laid to rest in 2010 in the Fromelles (Pheasant Wood) Military Cemetery, Plot 111, Row A, Grave 4, in France. Norma Staber is given the wooden cross that Reginald had in his pocket, and it is still intact.

His mother Auriol Agnes Jones signs for his medals on the 18th August 1922, her signature appears in the military file (page 47) as having received them. See Auriol Agnes Jones signature below.





A letter addressed to the Army and dated the 17th March 1967, is written by Auriol's eldest daughter; Molly Elizabeth (nee Jones) Hayes (Reg's half- sister). Page 45 of 52 in R. R. Wildman's military file.

"Dear Sir,

In reference to the Anzac commemorative Medallion Badge.

I wish to make an application for the Medallion Badge for Pte. <u>Reginald Raymond Wildman</u> No 1888, 2nd Battalion, who later, after Anzac landing and Gallipoli, was killed in France with either the 54th or 56th Battalion (4 years later I think.)

"Reginald Raymond Wildman was my half-brother, his mother and mine was Auriol Agnes Bradney (maiden name), then I understand, Wildman, and later married my father David Jones and I am the eldest of the family." "My mother was living in Yass when R. R. Wildman was killed in France. I have seen his name on the wall of honour at the War Memorial in Canberra, but I am not sure if it was with the 54th or 56th Battalion as two of my uncles were also killed in France about the same time and they were in 54th or 56th Battalion; John Bradney and Wentworth Bradney." "I don't think anyone else will claim the medallion of my half-brother as my mother and father have both been dead many years, and I have other things here my mother gave me belonging to her son. "Am I entitled to both Badge and Medallion? If so I would greatly appreciate receiving your reply and medal etc as soon as possible." Yours faithfully.

This now confirms that Auriol had for a time taken the Wildman name.

The Wildman family were John Robert Wildman (1851-1915) and Emma Bradney/Nichols (1856-1915) who married on the 25th December 1871. Emma was the 4th child and daughter of John Bradney (1822-1872) and Ann Louisa Nichols (1831-1914).

Emma and John Wildman had four sons. John Robert Wildman (1872-1946), Frederick William Wildman (1875-1951), George Negrus Wildman (1877-1935) MY GRANDFATHER, and Ernest Vane Wildman/Hearne (1880-1939), all a similar age as Auriol Bradney (1878-1932). Could one of these boys have fathered Auriol's child and that is why they took Auriol and baby Reginald into their home and then raised Reg with the Wildman surname. Remembering that George Negrus Wildman was my grandfather, this reflective journey has heightened my curiosity even more about my g-grandparents Emma and John Wildman, and I hope to gain a deeper understanding about the Wildman/Bradney relationship that transpired all those years ago, so I am off to find Norma Staber who may be able to shed light on who Reginald Raymond Wildman's father was.

Within a week, with the help of Mr. 'Google' and some super detective work I found Norma Staber! She answered my phone call and after a short conversation she invited me to visit, and I promptly accepted as she only lived 45 minutes down the freeway from me at Noraville! Two days later, cake in hand, I called on this delightful lady who welcomed me with arms of family history to ponder over. Although we spoke at length for 5 hours, there is no hard evidence to say who was the father of Reg Wildman was but she firmly believes that it was one of the 'Wildman boys' and George was closest in age. We have discounted Ernest as he was only 14. Auriol would never disclose who fathered her son, so we are no closer to proving to certainty, but happy with leaving it unsolved and I got to hold the cross from his pocket which was incredibly humbling.

Charles Andrew Hughes (1830-1906) married Mary Lowe (1832-1893) and then remarried to Mary Jane (nee Coneybeare) Sherriff / Hughes


Hi everyone. I am a member of Ancestry, and I find it very useful for filling in gaps in my Trees, though you have to take some information with a grain of salt. Recently I have been updating my records and found an interesting letter from Dorothy Agnes (nee Williamson) Hughes, wife of Leslie John Hughes. She was writing to a Betty Garrard about the Conybeer side of the family. I have found several variations of the spelling, which makes it interesting when looking through records. Conybeer, Coneybeer, Coneybear, Conybeare. I got in touch with Dorothy and asked her if I could use the info in her letter for a story. She said yes. So here it is. John Powsland Conybeer was born 1833 in Somerset, England and died 1911, in Granville, NSW. He married Mary Anne Hobbs, born 1833 in Somerset, England and died 1914 in Orange, NSW. They immigrated to Australia aboard the "Wallasea" and arrived on 27 Sep 1865 with 5 children. Apparently, he was moving to Australia for employment at Dales, a harness making business for the Coaches of the day.

Their first child was **Matilda Jane (Conybeare**), b 1853 in Devon, UK. Died 22 Feb 1924 Woollahra and was buried in Waverley Cemetery. She married 1878 Orange, to Walter William Evernett 1854-1932. They had 9 children- Frederick Clement 1878-1965, Percival John 1880-1947, Walter Leslie 1882-1964, Cecil Herbert 1884-1910, Bertrand Guy Gary 1886-1957, Mildred Jane 1888-..., Mabel Grace 1891-..., Norman Sidney 1894-1971 and Beryl Marion 1909-2010.

Child 2 John (Conybeer) b 7 Dec 1855 Bedminster, Bristol, UK. Married 6 Oct 1881 at Orange to Mary Bowyer, 1861-15/10/1899. They had 9 children-Mary Lena 1882-1956, Ruby Edna 1883-1946, Hilda Jacqueline 1885-1968, Eva Kate 1887-1933, Alfred John 1889-1937, Lilian Fanny 1891-, Irene 1893-1969 (Conybeare), Elsie Jane 1895-1898, and Ida Doris Madeline 1897-1974 (Conybeare). John was a saddler, a similar trade to his father. He also served in the Imperial Army in the Sudan 1884-1886. After his wife Mary died, he left his children with his parents and travelled to New Zealand, where he remarried on the 16 May 1905 at Wanganui. His new wife was Alice Allan 1869 NZ-1949 NZ. John and Alice (pictured right C1940) had 4 children-Edward 1905-1992, Frederick James 1909-1970, Annie Kate 1911-1996, Mary Alice 1912-1996. John died 1 April 1950 Wanganui and was buried at the Aramoho Cemetery.



Child 3 The Honourable **Frederick William (Conybeare)** known as Bill b 27 Sep 1859 Bristol, UK-30 May 1950 Sth Australia. He married 20 Feb 1886 to Margaret Jane Thomas- 21 May 1858, Kooringa-8 Feb 1940 St Peters. Bill and Margaret had 6 children- Olive Lillian Harriet (Coneybeare)-1887-1967, Ivy Muriel-1891-1898, Frederick Roland – b.1894, Edmund Harold -14/12/1894-1955, Victor Torrens-25/4/1896-25/10/1897, Herbert Llewelyn-b.16/4/1904. Bill was a Politician in South Australia and has quite an impressive resume. He was a Member of the House of Assembly for East Torrens 1893-1921 + 1924-1930. Speaker of the House-1915-1921. Minister Of Education-1908-09 + 1910-1912, member of 5 Royal Commissions, chairman of 7 wage boards, Secretary + Whip for the Labour Party for 10 years, Whip for the Price-Peake Government for 4 years, parliamentary representative on the Adelaide



University Council, Treasurer to the Adelaide Co-op Society Clubs-20 years, and president of numerous athletic clubs. He was also named Father of the House.

Child 4 **Annie Kate**, b 1863 Bristol, UK and d.1944 Orange. She married in 1900, Balmain Nth, to John Patrick Lindfield, b 1866. John was an Orchardist. They had no children.

Child 5 was our Mary Jane Coneybear (1864-1951) who married Charles Andrew Hughes (1830-1906). Mary Jane Coneybear was born in 1864, and her first marriage was to William Mather Sherriff (1859-1888) the 2nd April 1885, at Orange. Mary remarried to Charles Andrew Hughes (1830-1906) on the 17th May 1894* and her name is spelt as CONEYBEAR on the marriage certificate, which is held in the JNFS certificate archives. Mary and Charles Hughes had five children (Theodore Sydney (1896-1975), Isoline Freda Kate (1897-1989), Edwin Randolph (1900-1974), Lillian Mary (1903-1980) and Leslie John Hughes (1905-1986). Charles Andrew Hughes died on the 2nd May 1906 and his wife Mary Jane (nee Coneybear) Hughes passed away on the 28th September 1951, at Orange.



Child 6 **Evelyn Fanny (Conybeare**) 28/8/1866 Orange-10/5/1954 Rockdale. Evelyn was buried in Woronora Cemetery, Married 12/11/1890 at Forest Lodge to Alfred Horan Cunningham 1861-1935. They had 3 children- Clarence T 1891-1924, George A b 1894, and Evelyn Sophia Mary b 1896.

Child 7 **Edwin James b** 1/2/1868 Orange. Married 1891 in Orange to Gertrude M Hennessy. They had 2 children- Vera G b 1893 and Gertrude Minnie 1894-1984. Edwin served in the Boer War and died on the 16th June 1900, Bloemfontein, Free State, South Africa. He was buried in the President Brand Cemetery, Bloemfontein.

Child 8 **Alfred Henry** 1/2/1870 Orange-21/11 1934 Sydney. Married 1901 Unley to Marion Forrest Eglinton. They had 1 child- Alfred Theodore 1902-1979. Possibly worked for David Jones in some artistic position. Son Alfred was an Industrial Judge.

Child 9 **Elizabeth Lillian** 23/2/1874 Orange-9/11/1955 Orange. Married 1898 Orange to Alfred John Ross 1868-1946. They had 4 children. Mabel Jane-1898-1980, Edwin George 1901-1902, Alfred Charles 1903-1974 and George 1908-1980.

Child 10 **Charles Richard** 27/2/1877 Orange-20/5/1954 Orange. Married 1918 to Annie Moody Feltham 1885-1961. They had 4 children- Charles Henry 1918-1989, John Powsland 1919-1929, Grace Anne 1921-2005 and Evelyn May 1924-2017.

Child 11 **Theodore Sydney-7**/7/1872 Orange- 12/9/1889 Orange.

Dorothy said there was a 12th child, probably died young. I found an unnamed male child born in 1868 but could not find a corresponding death. Dorothy's letter was written in 1992, aged 85. She passed away in 2001. She sounded very upbeat when talking about the family and was able to recall details vividly. Further on in the letter she sounded a little despondent, as she remembered she was the last of the Hughes family in that generation. She said and I quote "I have had many blessings & wonderful friends along the way and am very grateful". I hope this outline will help family members extend their trees or give them a starting point to start growing one.

SARAH NICHOLS married RICHARD JOHNS on 29th April 1845

The remarkable lives of Sarah Nichols and Richard Johns were quite unknown to virtually all of us until the publication of 'The Story of JOHN NICHOLS – First Fleeter' in 1988. Kaye Purnell's very informative article printed on pages 266 to 268 told the story of these two people in great detail. All members from the Sarah line owe much to Kaye for her story.

I have endeavoured to add to Kaye's story over many years but this has been difficult. Richard's early death in 1866 at the age of 56 and Sarah's inability to read or write have been obvious issues. My reading of old newspapers has only turned up good stories about the Johns family at all times. Richard Johns must have been a very wise and well-respected person. He must have been a successful farmer in Nairne, South Australia before the whole family moved to Bochara near Hamilton in Victoria. All newspaper references to Richard after his death refer to him as Dr Johns. We now know that he was never a doctor but this only indicates the high respect he was accorded.

Upon marrying Richard Johns on 29th April 1845, Sarah took on three step-children – Richard 9, Mary 7 and James 4. (One of John's children had died in 1851) Richard, Sarah and the three children set sail from Sydney on 29th December 1845 for Adelaide. Fancy getting on a sailing ship when heavily pregnant with three young children. Phillippa Johns was born aboard ship, probably in the rough seas of Bass Strait, on 16th January 1846. What a way to have your first child!

Richard and his growing family moved immediately to Nairne, about 40 Km east of Adelaide, and started farming on firstly rented land rather than his own land. By 1861, Richard owned 333 acres of land about 2 Km north-east of Nairne. He sold all this land at auction on 11th April 1861 because of ill health and then moved to Bochara, near Hamilton in Victoria. The sale notice states that there was a stone house of six rooms together with a garden of one acre on Sections 5287 and 5295, and a stone house on Section 5303 which was 1 Km closer to Nairne. It would seem that Richard had hired help and it seems likely that John Edmonds and John Shemeld were employed as farm labourers by Richard Johns.




John Henry Edmonds was born in 1831 in Surrey England and after being a sailor for some years, migrated to South Australia with his sister, Susannah, in 1853. John Edmonds married the seventeen-year-old daughter of Richard Johns, Mary Johns, in 1855 and then in 1858, the seventeen-year-old Susannah Edmonds (John Edmonds sister) married Richard Johns, eldest son of Richard Johns. It is quite likely that Susannah Edmonds was employed to help Sarah Johns with her large family.

By the time the Nairne farm was sold in 1861, Sarah was the mother of Phillippa 15, Thomas 13, John 11, Elizabeth 10, Esther 7, William 5, Emma 2 and Henry 8 months. It must have been quite an exercise to move the whole Johns Family, including the families of John and Mary Edmonds and Richard Jnr and Susannah Johns, to Bochara. It would seem that another farm worker employed by Richard Johns, John Shemeld, also moved to Bochara at the same time.

Richard Johns died in 1866 in Bochara and was buried in Hamilton. His youngest child, Sarah was born in Bochara and was just two when he died. Sarah Johns was a widow at just 44 years of age with eight unmarried children ranging in age from 18 to 2. Her eldest child, Phillippa, was married in 1863 at the age of 17 to William Dellar. The extended Johns family by now had numbered twenty-five with a 44 year-old widow as the 'head' of the family. Sarah Johns was already the step grandmother and grandmother to 9.

In 1871, John Shemeld (pictured right) married the nineteen-year-old Elizabeth Johns. I assume that he came to Victoria as a Johns Family farm labourer. Once again we see that staged moves from employee to son-in-law take place. John Shemeld, just like John Edmonds, had come from a difficult background to start a very respectful life as part of the Johns family. John Shemeld's father, John Shemeld Snr (1805 – 1858) was a convict who was transported to NSW in 1830 and made his way to Adelaide by 1840. John married Elizabeth Moses, a young widow, in 1841 and John Shemeld was born in the same year. John's young life was very difficult – his mother died in a kitchen fire in 1844 when he was 3 and a year later his young brother died. Meanwhile his father made several court appearances in Adelaide for various misdemeanours. His father married again in 1853 and had at least three more children. John's father accidentally drowned in a creek in 1858. He then had little to do with his family and became more attached to the Johns family.



The Johns family moved to a farm at Clear Lake in 1876 next to a farm owned by Johann and Anna Jensz, a German speaking family who had moved from South Australia some years earlier. The last three Jensz children, Albert, Richard and Lewis (my great uncles) were born between 1883 and 1887 and all had several Johns connections. They were all born at home and delivered by Mrs Sarah Johns and Mrs Susannah Johns. The three births were then registered by the local Clear Lake register of births, deaths and marriages – Mr John Henry Edmonds. All three Johns names appear on each of the Jensz birth certificates. The link between the Johns and Jensz families was further entwined in 1885 when the 23 year old Richard Johns, eldest son of Richard and Susannah Johns married the seventeen year old daughter of Johann and Anna Jensz, Mary Elizabeth Jensz.

In 1937, my father, Victor Jensz, grandson of Johann and Anna Jensz married my mother, Doris Fulton, great granddaughter of Richard and Sarah Johns.

The death of Sarah Johns in Dimboola on 12th September 1907 was the final chapter of the amazing lives of Richard and Sarah Johns. Richard had 13 children, 4 from his marriage to Margaret Nancarrow and 9 from his marriage to Sarah Nichols. There were 104 grandchildren – 81 were from Sarah and she had 23 step grandchildren. Sarah was born in Sydney and she lived in NSW for 23 years. Then followed 16 years in South Australia and 46 years in Victoria. Richard Johns lived in Cornwall for his first 28 years and then in NSW for 6 years before moving to South Australia. He only lived for 5 years in Victoria and Sarah was then a widow for 41 years.

By about 1950, the descendants of Richard and Sarah Johns were obviously very numerous and almost all lived in the western part of Victoria from Portland to Mildura except for John Johns (1849 - 1929) who moved to Gilgandra, NSW with his family.

A large crowd of descendants paid tribute to the life of Sarah Johns on Saturday 15th September 2007 to commemorate her death on 12th September 1907. A moving service was held at the Dimboola Cemetery on the day exactly one hundred years after she was buried in 1907. It was a fitting memorial to the person who was probably the last surviving child of a First Fleet Convict and the matriarch of the Johns Family.

SUSANNAH NICHOLS married CHARLES KINSELA on 7th MARCH 1837

Hello fellow "Susannah" and other John Nichols Descendants. I do hope members and their families are keeping well and safe and I wish you all Peace and Joy for the coming Christmas. May the New Year 2024 bring good health and happiness to each and every one of our members!

You might be wondering why I am featuring a story about Mary ADAMS and the reason is, as mother of Charles KINSELA who was the husband of our Susannah NICHOLS, Mary shared a pivotal part in the life of this couple and their children.

My four times Great Grandmother, Convict Mary née ADAMS TRISTRAM, has always intrigued me and over the years I have imagined what her life entailed. Not least of the intrigue was the difficulty, for me and others, in being able to prove her parents in Hampshire. I am about to purchase a DNA kit through Ancestry in the hope this might help solve this "Brick Wall". Prior to doing this I am going to enter on Ancestry, a "possible" Baptism for a Mary ADAMS, 11 Mar 1781 in Fareham Hampshire, England, to parents William ADAMS and his wife Elizabeth. Fareham is only 8.3 Miles from Portsmouth Hampshire where Mary was tried and convicted on 6 Oct 1803 at age 22. I will also endeavour to add possible siblings in the hope I receive a connection from this "line of hope." Death entry 18 Aug 1862 in her Family Bible says age 80 and Funeral details given by son Charles says in her 82nd year and "Find a Grave" lists her birthdate as 3 Aug 1782.

Mary ADAMS was tried at Southampton (Portsmouth) Quarter Session 6 October 1803. The Hampshire



Telegraph 22 August 1803 reported: This morning Mary Adams was examined before the sitting Magistrates, at the Guildhall, on a charge of her having stolen a quantity of lace, muslins, &c. from the shops of Mr. Paine and Mr. Allen, drapers, at Portsea. After a short investigation she was remanded for a further examination and sentenced to 7 years transportation and arrived on our shores 11 April 1806, after a very long voyage on board the Convict Ship "William Pitt" (see left). All women Convicts were in good health; however two convicts had died on the voyage. Three months later Enoch KINSELA (born John

KINSELAGH), Forger, Extortionist and Bigamist, arrived 12 Jul 1806 as a convict on board the Convict Ship "Fortune".

A report in the Sydney Gazette, dated 25th January 1807, six months after his arrival, shows an advertisement placed by Enoch KINSELA, Manager of the Government Salt Works at Rosebay. Enoch's intelligence, literacy and business acumen and no doubt cunning must have stood him in good stead in the new Colony because varying notices appeared in the Sydney Gazette, advertising his business premises at 6 Upper Pitt Row, selling candles, hard soap and later advertised the establishment of a brewery selling bulk beer and at a later date, bottled beer. By now his business had expanded to include number 5 Pitt Row.

During this time Enoch formed a liaison with our Mary ADAMS, convict per William Pitt, arriving in the Colony 11 April 1806. Enoch's former forays into marriage must have 'put him off' formalising this partnership even though the quasi-official attitude was that transportation rendered void any current marriage. Enoch and Mary did however have a family together, Eliza born 12 March 1810, Thomas born 4 June 1812 and Charles born 31 July 1814, five weeks after Enoch's death, aged 44 years by his Baptism Certificate and understated as 37 years on his burial certificate. A good lesson for all of us – never trust details on Death Certificates.


Enoch's fortunes in the Colony between his arrival and his death eight years later on 21 June 1814 fluctuated greatly. He was granted a Ticket of Leave on 28 February 1811 which was cancelled almost immediately when he was given his Certificate of Freedom 11 April 1812 after the expiry of his sentence on 9 March 1812. We can but wonder how Mary coped with three small children, the eldest four years old, to raise

without her partner and their father. Enoch had certainly lost all his assets. It would appear by notices in the Newspaper of the time, all houses had been either sold voluntarily or by forced sale to cover debts. Poor Mary! We do know that both Mary and Enoch were both well-educated and this would have stood Mary in good stead.


Fortune appears to have smiled on Mary as just under two years after Enoch's death, Mary ADAMS married William TRISTRAM 5 Jun 1815 at St Phillip's Church of England, Sydney. I do wonder if they were acquainted prior to Enoch's death. William, who was also a Convict, certainly was in gainful employment and so gave Mary and her three little children the security she deserved. I hope it was a "love match."

Sadly, Mary's eldest child and only daughter Eliza KINSELA, died on 29 May 1822 at the age of twelve years, (listed as 13 years on the Burial Certificate) and buried at Devonshire Street Cemetery, Sydney. By this time Eliza's stepfather William TRISTRAM was the Gaoler at Liverpool Gaol and still District Constable, a position he had held since his appointment 12 August 1820.

The 1825 General Muster lists Adams Mary, Free by Servitude, per ship "William Pitt", 1806, Sentence 7 years, wife of William Tristram living at Liverpool. William Tristram in the 1825 General Muster lists his employment as Gaoler at Liverpool.



William Tristram arrived on the "Guildford" on 18 Jan 1812 and was employed as a stone cutter in 1814. He was appointed constable in Sydney by 1820 and Liverpool in 1825 - 1828. He was appointed gaoler at Newcastle gaol on 18 May 1845. Mary was employed as Matron of the gaol.




In 1848 the prisoners confined in Newcastle gaol were transferred to the new gaol at Maitland. They were accompanied by William and Mary Tristram who became the Gaoler and Matron at Maitland Gaol.



Abovet: Maitland Gaol showing Gaol Governor's Residence on the left. William and Mary were dismissed from their positions at Maitland after the escape of prisoners Davidson and Smith in 1849 and because it was found that William had been drawing from government rations for his private servant. They auctioned their household goods and returned to Sydney.

Mary Tristram Bible Entries: Mary Tristram nee Adams made many entries in her Family Bible which was printed in 1800. Mary's entries appear to begin with the Birth of her son Thomas Kinsela, followed by the Birth of her son Charles Kinsela. Thomas Kinsela's Death entry is also noted below his Birth entry. Subsequent pages list details of Birth, Baptism and infant Deaths of her grandchildren from 1838 to 1857



He died on 6 January 1938 at Gympie, Qld, at age 65.
- 1. Muriel Gladys MUDGE was born on 26 January 1895 at Milton. She married Henry SWEETNAM, son of John SWEETMAN and Annie BARBER, in 1916 at Murwillumbah. She began military service on 12 October 1942, enlisted at Brisbane, Qld. Service No. Q265330 with the Australian Women's Army Service. The families of John Joseph Manuel and Emma Jane Heaney

The John Joseph Manuel and Emma Jane Heaney family line descends from the second child and first son of John Joseph Manuel (1828-1901) and his wife Susannah Nichols (1829-1899), daughter of Charles Nichols (1804-1867) and Margaret Finlay (1800-1873). John Joseph Manuel (1859-1918) married Emma Jane Heaney (1860-1946) in 1881. Their children were:

- Emma Susannah Manuel (1882-1974) married in 1909 at Balmain South to Joseph Solomon (1880-1948)
- Charles Westrock Manuel (1884-1962) married 1911 to Ethel May Harlon (1881-1937)
- Heleanor (Nellie) Manuel (1886-1973) married 1912 to John Nicholas Feltham (1884 Vic-30 Oct 1968).

John Joseph Manuel's probate packet was transcribed in the December 2004 newsletter and his career as a policeman was featured in the June 2008 newsletter. In this issue we turn to his wife Emma Jane Manuel.

Emma Jane Heaney was born in 1860, the daughter of Henry Heaney and his wife Emma Heaney nee Elwin. Emma was a dressmaker.² John Joseph Manuel and Emma Jane Heaney married on 24 October 1881 at Sydney. John Joseph Manuel passed away on 1 July 1918.³

Emma Jane Manuel lived until 25 June 1946.⁴ Her death notice recorded:

MANUEL -June 25, 1946, at her residence, Marine Parade Watsons Bay, Emma Jane, relict of the late John Joseph Manuel, and dearly beloved mother of Emma (Mrs. J. Soloman), Charles, and Nellie (Mrs. J. Feltham), aged 86 years.⁵

Her funeral notice shows that she was buried at the Church of England Cemetery, South Head:

MANUEL -The Relatives and Friends of Mr. and Mrs. J. Soloman and Family, Mr. C. Manuel and Family, Mr. and Mrs. J. Feltham and Family, are invited to attend the Funeral of their dearly beloved Mother, Mother-in-law, and Grandmother, Emma Jane Manuel to leave her late residence, Marine Parade, Watson's Bay, This Wednesday, after Service to commence at 2.15 p.m. for the Church of England Cemetery, South Head. Charles Kinsela Pty., Ltd., A.F.D.A., Est. 1830. Taylor Square, Darlinghurst. 'Phones FA4136-7-8.6

Emma Jane Manuel lived most of her life at 23 Marine Parade, Watsons Bay. Her executors were her two eldest children, Charles Westrock Manuel and Emma Susannah Solomon. Her will dated 18 March 1920 divided her estate equally between her three children. Her whole estate was valued at £1342.10.42. The property at Watson's Bay in the Municipality of Vaucluse, Parish of Alexandria, Count of Cumberland (Certificate of Title Volume 3756 Folio 100), comprising Lots 2 and 3, was worth £1125. The land, of 66 feet by 140 feet, fronted both Marine Parade and No. 9 Cliff Street (formerly Military Parade), and the houses were described as a "Double fronted weatherboard cottage, four rooms and kitchen and attic, iron roof and double fronted weatherboard cottage, three rooms and kitchen, iron roof." Her furniture, worth £22.15.0, was listed as "1st Bedroom: 1 Wardrobe, 1 Cedar Chest Drawers, 1 Easy Chair, 1 Bedroom Chair, 2 Pictures, 1 Whatnot, 1 Occasional Table; Kitchen: Crockery Cabinet; Attic: 1 Iron Double Bedstead and Mattress, 1 Oak Washstand, 1 Dressing Table, 1 Sideboard and Overmantle, 2 Chairs, 1 Hanging Wardrobe and 1 Hall Stand." In addition her assets included two Mutual Life and Citizens' Assurance Co. Ltd. insurance policies worth £60.4.3 and an account with the Commonwealth Savings Bank of Australia, Rose Bay, worth £139.14.9. She also owned jewellery comprising "One old fashioned gold watch (out of order) £2.10.0, One gold brooch, £2.10.0 Two tie pins – one with cat's eye and one imitation stone, 10.0, totalling £6.10.0".

Both John Joseph and Emma Jane Manuel have many Manuel family descendants alive today.

ANN PUGH NICHOLS married JOHN KELLICK on 18th October 1825

John Kellick's Mother, Jannet (Jane) Gardiner nee Hay, Born c1780 – Died 04th May 1818 Part 1

John Kellick is my great-great grandfather and my first Australian born ancestor on my mother's (Joan Holman nee Kellick) side. John Kellick was born in Bligh Street, Sydney, Australia on the 3rd of July 1803 and was baptised at St. Philip's, Church Hill, Sydney, Australia on the 25th of March 1804. It was noted on John's baptism certificate that his mother was Jane Hay, his father was John Kellick and the baptism was registered at St Phillip Church, Sydney. It is noted on John Kellick's death certificate that his father was John Kellick, a gunner on board HMS Gluton and his mother's name was Jane Hay.

There is a good deal of information on my great-great grandfather John Kellick but no mention of his mother under the name of Jane Hay living in Sydney in the early 1800's.

Below is an extract from part of an article written by Sue Tuck for the John Nichols Family Society (JNFS) November 1984 Newsletter (the society's second newsletter) detailing the research which was carried out to establish the name of John Kellick's mother.

There is a good deal of information on John Kellick junior but we could find no mention of his mother under the name of Jane Hay. On checking the convict indent, Sharon (Draper) could not find a Jane Hay, so all the women with the Christian name of Jane were noted, one of which was Jannet Gardiner. In the meantime I came across a letter written by John Kellick junior dated the 28th of August 1826 in which he applied to the Sydney Male Orphan School, Sydney for the release of his (half) brother George Coulson, so that he could enter into an apprentice carpenter with him. We now had another name for his mother, Jane Coulson.

With this name we hit the jackpot and discovered the following; Jane Gardner had four children to George Coulson, they were Elizabeth born 18th of September 1809, Mary born the 14th of May 1812, Jane born on the 1st of October 1813 and George born on the 26th of May 1816. Now our question was why was George in the Sydney Male Orphan School? He had been admitted on the 2nd of January 1822 but listed beside his name under the heading "Parent" was the name Jane Dew. We wrongly assumed that Jane Hay/Gardiner/Coulson had either remarried or taken another name. Kaye (Purnell) then found the death of a Jane Gardner in the Birth, Death and Marriage Records for the 4th of May 1818 and now we feel quite sure that this is in fact John Kellick's mother.

Our reasons for this is as follows; on checking through some early musters we found in 1811 Jane Gardiner is listed as being transported on the Glatton, the 1814 muster shows Jane Gardiner as arriving on the Glatton and being the wife of G. Coulston with five children (we had accounted for four). Then in the 1822 muster there is no Jane Gardiner/Coulston listed. On the 1822 muster George Coulson junior is shown as living in the Sydney Male Orphan School while his sisters Elizabeth, Mary and Jane are listed as being at the Parramatta Orphan School.


In regard to the name Jane Drew, we assume that George junior and probably the three girls were placed in the care of Jane Drew (a washerwoman of Farm Cove) and when her husband John Dew died on the 14th of July 1821 Jane Dew put the children into the orphanages. The fact that George Coulson senior is shown in the Sydney Gazette (Saturday the 25th of July 1818, page 4) as intending to leave the colony for England in 1818 further supports our assumption that the children would have been classed as orphans.

After the great detective work carried out in the mid 1980's by the founding members of the JNFS we now know that John Kellick's mother was Jannet Gardiner. At the time that the above research was carried out

the JNFS members were busy collecting material for the John Nichols First Fleeter book for its publishing in 1988 in time for the 200 year anniversary of the landing of the First Fleet in Australia and would not have the time to research Jane any further.

There are a number of online family trees including the JNFS web site that have John Kellick's mother as Jane Hay alias Janette Gardiner. There was one internet site that stated that Jannet Gardiner and Jane Hay were not the same person. I think that a lot of people have used the information from the JNFS site and put it in their family trees and because it was not their direct line have not researched her further.


As John Kellick is my direct line, I am trying to research Jannet Gardiner/Jane Hay further but with limited success. I have tracked down where her court record of the Cumberland Quarter Sessions are held and was able to purchase a copy of her Court Records. The record state in part that Jannet Gardiner was the wife of William Gardiner. I have not so far been able to find any records for her birth or marriage to prove her maiden name was Hay but as Hay is listed on her son, John's birth and death certificates as his mother's maiden name, I am confident that her name is Jannet (Jane) Gardiner nee Hay. It was the practice of that time that the sentence of *transportation beyond the seas* effectively terminated the marriage, leaving both Husband and Wife to remarry and this may be the reason that she took on her maiden name Hay. As for the Jannet/Jane christen names, it appears that she either took on or was given the christen name Jane as she is referred to as Jane once she arrived in Australia, so I will refer to her as Jane Gardiner after she arrives in Australia.

Cumberland, the Jurors for our lord the King upon their Oath that John Thompson late of the parish of Saint Bees in the county of Cumberland labourer and Jannet Gardiner late of the same place Wife of William Gardiner on the third day of March in the forty first year of the reign of our Sovereign Lord George the Third, now King of Great Britain, and so forth with force and arms, at the Parish of Saint Bees in the County aforesaid, five silk handkerchiefs of the value of ten-pence, the goods and Chattels of Peter Dixon then and there being found, then and there did feloniously steal, take, and carry away, against the peace of our said Lord the King, his Crown and Dignity.

Jannet Gardiner nee Hay boarded the ship HMS Glatton captained by Captain James Colnett along with 129 other females and 271 male convicts on the 12th of August 1802 in preparation for the 169 day voyage to Sydney, New South Wales, Australia. Jannet Gardiner appears to have become pregnant during the voyage to Australia.

Seven weeks after arriving at Sydney Cove and almost 10 months after she left England Jane gave birth to a son whom she named John Kellick. It is noted on her son's John Kellick's Baptisms Certificate that the father was John Kellick and her name as Jane Hay and on his Death Certificate it was noted that his father was John Kellick and that his father's Occupation was 'Gunner on board HMS Glutton'.

The general consciences among the majority of family history researches is that Marine Gunner John Kellock was the father of Jannett Gardener's son John Kellick.

Serving on board HMS Glatton at the time Jannett Gardener was transported to Australia was an Officer, Marine Gunner John Kellock. It was common practice at that time that on Navy ships that the Offices were able to have a servant for the voyage and it appears that John Kellock chose Jannet Gardiner and it appears she became pregnant to him during the voyage to Australia. The Kellock/Kellick surname and the Ship HMS Glatton/Glutton may have either been a spelling mistake or a problem with Jannet's Northern English accent.

John Kellock was born on the 4th of May 1770 in Burntisland, Fife, Scotland and married a widow Sarah Sergeant (nee unknown) on the 13th of June 1796 at the Minster Church, in the Parish of Minster Isle of Sheepy Kent, England. In the Minster Isle parish marriage records it noted Sarah Sergeant as a widow. John Kellock died on the 19th of September 1818 at the Plymouth Hospital, Plymouth, Devon, England.

HMS Glatton arrived in Sydney on the 11th of March 1803, disembarked its consignment of convicts and supplies and departed on the 8th of May 1803 with John Kellock on board for the return trip to England.

I will finish off now but will continue in the next Newsletter Jane's story of her time in Australia.



SOPHIA NICHOLS married ALEXANDER PHILP on 24th February 1823, then formed a relationship with PATRICK MARKEY from 1839

Whilst researching the WW2 site for photographs prior to the recent reunion, I came across the military file of a remarkable man who I believe deserves to have his story told as I feel the members would enjoy following his life story as much as I did reading through his military service file, following his adversity and the obvious challenges and adventures of Horace Collier.

Horace Collier was born on the 18th October 1894 at Broken Hill, the son of Elizabeth Nolan (1865-1941) and William Henry Collier (1865-1945). When WW1 is declared Horace is too young to enlist legally so he assumes his cousin's identity and enlists at Randwick, Sydney, stating his name is 'Chas Alick' Blizzard,' aged 22 years and 3 months who is employed as a Tram Conductor. When filling out the medical page his name is spelt Charles Alec Blizzard, 5'11" tall, weighs 164 lbs, chest 38" and religion C of E with his sister Elizabeth Collier as NOK.

With the Service No: 4066 he completes his basic training. On the 2nd March 1916 he writes a 'Stat-dec' that states "That my correct name is Horace Collier. That being under the age of twenty one (21) years at the time of enlistment I assumed my cousin's name, Chas. Alexander Blizzard and have been using that name for all my military records since the date of enlistment." Records adjusted, Horace is assigned to the 13th Battalion and embarks from Sydney on the HMAT A15 Star England' on the 8th March 1916, for the Middle




East.

By mid October 1916, Horace spends his 21st birthday (18.10.1916) fighting at Alexandria, with the 17th Brigade, 2nd Division.

On the 27th October 1916 he 'Marched into France' with 13th Batt. and on the 5th February 1917 is promoted to Lance Corporal. The next notation in his military file states "MISSING IN ACTION' dated the 11th April 1917

19th May 1917: Confirmation received that Horace Collier is now a Prisoner of War, having been shot in the left hip, he was captured at Reincourt and is now interred at Gefangenenlager Hamelin POW Camp, in Germany.



Nothing is written in his military file for the next nineteen months, except a reply letter written by his mother stating "that she is grateful to hear the news that her son Horace is still alive albeit in a POW Camp in Germany, as she lost her older son to the Great War on the 2nd April 1917, and finds solace in knowing Horace didn't suffer the same fate as his brother. The letter is dated 31st October 1917.

Around 14 months go by with no further documentation in his military file but I stumbled on an extract from the Aust. Red Cross – Missing and Enquiry Bureau Files which appears as it was written below. It reads:

Extract taken from the Aust. Red Cross Society – Wounded and Missing Enquiry Bureau Files.

"Escaped from Germany on 7th – now in Holland at ESCHEDE" Would you be good enough to cable my mother, Barmedman, N.S.W. Extract Rec. from man. Dated 9.12.1918

Horace has survived the battlefields of Egypt and France, being captured and interred in a POW Camp in Germany, has escaped from the POW Camp and made his way to Holland. We believe that with help from the local resistance he made it to Hull in England.

20th December 1918: Arrived in England. Horace takes leave in the UK and also goes AWOL, which is overridden and extended leave granted to 3rd February 1919. Eight weeks later Horace arrives back to Caloundra, in Queensland, and is discharged from




the Army on the 8th August 1919. We believe he initially settled at Merrylands, Sydney, as the 1920 census has him residing in the western suburbs of Sydney and that may be where he met his future wife; Florence Adelene Bysh (1899-1986) whom he marries in 1920, and her photograph appears right of page. Horace is now aged 23 & 10 months.

In 1921 their daughter Grace Adeline Collier (1921-1928) is born and the family relocate to Muckalilla, in Queensland. Tragedy strikes when a branch from a tree, where Grace is playing falls on her, and she dies on the 6th August 1928. The family move several times from 1930 to 1949, as we believe Horace is working as a Cane Cutter and probably chasing employment, but eventually settles in Goondiwindi, Queensland in 1936.

But that is not the end of Horace Collier's military career!

On the 28th October 1940 Horace Collier enlists for WW2. His Attestation form states he age 45, a cabinet maker and fought in WW1 in Egypt and France with the 13th Batt. giving the name of his daughter Elizabeth who is the NOK. He also states he is married to Myrtle 'Nellie' Philp (1911-1984) the daughter of Alfred Henry Philp and Rosina Gertrude Claven, Alfred being the son of William Philp and Sarah Ann (nee Harvey).



Horace is allocated the Service No: 50618, states he is now 6' tall and his photograph taken from his military file appears right. Note he has three stripes on his shirt signifying he is a Sergeant. Horace spent a total of 1,809 days in military service and was attached to the 14th Aug. Garrison Batt. He spent the majority of his time stationed in Darwin and the Northern Territory.

On his discharge paperwork Horace states he is married and resides at Albert Street, Caloundra, in Queensland and has five children with four under the age of 16 years. Horace is now 48 years and 11 months old and was discharged as Sgt. on the 15th October 1945.

We know his son Brian William Collier (5.11.1946-29.10.2007) from the 2nd marriage, wrote to the Army asking about his fathers will, after Horace died on the 26th June 1970, aged 74, at hospital, in Crows Nest, Queensland. Horace was buried in the General Cemetery at Toowoomba. The will of Horace Collier could not be found and was not in his WW1 or WW2 records.

Myrtle Ellen Philp died at Hospital Crows Nest, Queensland on the 26th March 1984 from Lung Cancer, and was buried in the Toowoomba Cemetery.

We certainly thank Horace Collier, a remarkable man who patriotically answered the call to arms when his country needed him and his service has enabled those who came after him to enjoy the freedoms and lifestyle we all enjoy today in this country.

An Historical Guide to Sydney - Green Plaques Idea from member Stephen Cummings

Take a walk through history with the compliments of the State Bank. With the help of the Royal Australian Historical Society and the Sydney City Council, one hundred and one plaques have been erected around Sydney, celebrating historic places, people and events. Start walking and experience the Sydney of yesterday today.

- 1. Campbell's Bank Circular Quay West. The Rocks. On this site in 1819 Robert Campbell, Sydney's leading merchant, opened Australia's first savings bank. He accepted shillings, dollars, dumps, and rupees. And convicts.
- 2. History House 133 Macquarie Street. Built in 1871 for the Parramatta politician George Oakes, History House is now the home of the Royal Australian Historical Society. They'll help you to find out more about historic Sydney.
- 3. The Lands Department Bridge St. Between Gresham and Loftus Sts. You can explore your local history at this treasure house of property maps, and you can look at the many statues of Australian explorers in the niches outside.
- 4. Treasury & Audit Office Bridge St, corner. Macquarie St. a most refreshing historical stop it's now the Inter-Continental Hotel. A wonderful combination of old and new, where you can dine in the Treasury Restaurant, have a drink in the courtyard or hold a meeting in the Premier's Room.
- 5. The First Execution Cnr. Essex & Harrington Sts. In 1788 convict Thomas Barrett stole butter peas and pork peas and pork from camp provisions. This is as far as he got. A gallows tree located here between the male and female convict camps was used for the deed.
- 6. St James' Church King St., near Macquarie St. This church is a beautiful example of Georgian architecture. It was originally intended to be a courthouse, but there must have been a sign from above, for it was converted into a church at an early stage of construction.
- 7. Tank Stream Hunter Street. When the First Fleet landed in Sydney Cove, it was this 'fine stream of fresh water' which attracted them. Over the years the Tank Stream became severely polluted by the people of the new colony. It now serves as a storm water channel running underneath the city streets.
- 8. Mort's Wool Store Young St., corner Albert St. Before Thomas Mort established specialized wool sales on this site, local trading was disorganized. Buyers often stopped wool growers on the road to Sydney and persuaded them to sell their wool before they could find out the real market price.
- 9. Legislative Assembly Chamber Parliament House, Macquarie Street. The home of Australian democracy actually had its beginnings as the Surgeon's Quarters of the Rum Hospital.
- 10. The Supreme Court Elizabeth St., corner King St. This building was the first permanent seat of justice in New South Wales. In the early days the wind whistled through the rooms and the noises of horses and carriages outside made working difficult.

These are the first 10 green plaques, and future Newsletters will contain details of the remainder. Member and past Secretary, Stephen Cummings is on a mission to photograph all 110
